

PATMONT UNMOLESTED

'DISAPPEARING PREACHER' FILLS DATES IN CENTRAL IOWA AND DEPARTS

ADDRESS AT IOWA FALLS LARGELY SELF DEFENSE

Might Have Been Arrested Easily Is Wanted by Eastern Officers—Reiterates That Charges Against Him in East Are Unfounded and That He Is Ready to Answer Accusers.

Special to Times-Republican. Iowa Falls, Feb. 3.—The Rev. Lewis R. Patmont, known in the Midwest as "the disappearing preacher," was greeted with a packed house at the Methodist church in this city when he addressed a union meeting of all of the protestant churches. The speaker left the impression with his hearers that he was in imminent danger and might be assaulted or kidnapped again, hence his departure from the city seems to have been a secret.

He was billed as a noted exponent of temperance, but little if anything was said during his talk relative to this great cause. He devoted much of his time to his own domestic troubles and to the recital of his harrowing experiences when kidnapped and held a prisoner in a farm house for fifty-one days. He laid considerable stress on the menace of unrestricted immigration and of his work among the Poles, Slavs and others in the east and in Wisconsin. A free-will offering was given him which was announced would first go towards his personal expenses and the rest to the publication of a Polish paper called the Standard, published in Milwaukee. He stated that the charge against him in the east for arson was wholly unfounded and that he would proceed there as soon as possible and prove his innocence.

No Effort at Arrest. Although the report current here that he would be taken into custody while here on the arson charge, the officers knew nothing of any warrant and Patmont was unmolested although his friends seemed unduly excited over his safety while in the city. If he is being treated by sleuths as has been intimated, no one of the Sherlock Holmes type showed up here, so far as is known. If he had been wanted very badly by the police, he would have been easily arrested here as he spent several days in this city and vicinity, and his whereabouts seemed to be known in St. Paul, Milwaukee and other cities. The ministerial association of this city requested Patmont a hearing at the request of Pastor Lewis of the Christian church at Robertson who has known Patmont for some time.

WILLIAMS FOUND GUILTY.

She will have two small children without support. Williams went to the Bedell home with his sister and his wife, to demand an apology from Bedell for alleged insults to his wife when she was in his employ at a candy factory. Mrs. Wilson also had words with Bedell and urged her brother to demand an apology from Bedell.

The old couple was brought to the station late in the afternoon by Officer Ed Larson and Health Officer Roy R. True, and a charge of vagrancy placed against them. The police declare the old people were destitute and in danger of starving in the little tattered shack where they lived at Avenue H and Twentieth street.

The case was continued in police court Tuesday morning without action. County Attorney Swanson announcing his intention to the court of filing a charge of insanity with the county commissioners against Mrs. Long. Refuse to Go to Poor Farm. Since early last fall they have been furnished coal and fuel by the county. Of late they have repeatedly refused to go to the county farm to live, and Supervisor of the Poor Abbott has quit suing them for the same reason. He did this, they commenced to call on Mayor Snyder, to whom they insisted that the city keep them.

This led the mayor to complain to Chief Vein Monday morning, after the two old people had again refused to go to the county farm. The chief ordered the property less than a year ago from Mrs. Halley for \$2,900.
