Cameroon Tells of Growth

President Cameron in his annual address reviewed the reports of the state fair presidents in the past twenty years. He pointed out that the receipts of the fair in 1895 were \$51,633.33 and in 1915 they were \$165,644.40. The amount paid out in premiums in 1895 was \$17,710 and in 1915 was \$89,588.75. Concerning the fair of 1915 he said: "I can only say of the fair of 1915, and I believe I voice the sentiment of the entire board and the patrons of the fair, that from an exhibit standpoint it was the greatest ever held in Iowa but in the United States. That is putting it pretty strong but that has been the almost unanimous opinion of expert writers on fairs. As you all know, the weather conditions of this year were not of the best, especially at the commencement of the fair, and the second week of the only week of sunshine we had all summer and the farmers were busy threshing out of the shock and staking their grain. But taking everything into consideration, I think we may congratulate ourselves that we did so well."

Chappel, director of the Iowa weather and crop service, was unable to give his annual summary of the crop yields and values at the convention today because he has not yet sufficient data at hand to make a report. Dean Charles F. Curtis of Ames, member of the Iowa Panama-Pacific exposition commission, told of Iowa's winnings at the big world's fair. John Coverdale, of Ames, leader of county work, discussed the question of the county agent and how to organize agricultural associations. D. W. Norris, of Marshalltown, chairman of the Iowa good roads commission, discussed the road problem in Iowa. Gordon J.
