Death claimed two veterans at the soldiers' home Sunday, John Payton, of Centerville, who died at 9:35 Sunday morning, and Michael Fox, of Winthrop, who passed away at 5:20 the same morning. Payton came to the home from Centerville on June 10, 1918, and died of cerebral hemorrhage. He was born in Shelby county, Missouri, Oct. 23, 1835, and enlisted in Company D, Sixth Iowa infantry, Feb. 14, 1862, at Centerville. He was discharged Feb. 17, 1864, at Scottville, Ala., re-enlisted the same day in the same company, and was a veteran and discharged at the close of the war on July 20, 1865, at Davenport. Payton was a widower and leaves two sons and two daughters. They are Elbert and George, of Centerville; Mrs. Josephine Holden, Spokane, Wash., and Mrs. Ella Stevens, whose address is not known. The body was sent to Centerville today. Michael Fox came to the home March 7, 1918, from Winthrop, and died Sunday morning of valvular heart trouble. He was a native of Germany, where he was born on New Year's day, 1839. On June 1, 1863, he enlisted in Company F, One Hundred Forty-eighth Pennsylvania infantry, at Sunbury, Pa., and was discharged June 24, 1864, at Washington, D. C. He leaves four sons, George R. Dubuque; W. H. Independence; A. T. Fox, Walnut Grove, Minn.; and J. F. of Revere, Minn. There is also a daughter, Mrs. J. H. Pidgeon, Arapahoe, Colo. Funeral services will be held Tuesday morning at 10 o'clock from assembly hall, in charge of Chaplain H. J. Pratt. Burial will be in the home cemetery. MRS. NICHOLS REAPPOINTED. Old Member of Library Trustees is Retained by Council. Mrs. H. H. Nichols, member of the board of trustees of the public library, was reappointed for a term of five years beginning April 5, by the council this forenoon. father, Milton J. Hussey, of Albion. The petition says Hussey is aged and infirm and unable to care for his property. USES KNIFE IN FIGHT. Negro, Advertising Confederate Army, in Real Battle. One white man in bed with a broken rib, one negro and another white man cut and bruised, are in jail, being three of four principals in what might be called a race war that broke out near Seventh avenue and Nevada street Sunday afternoon. The fourth participant, William Weinand, of this city, arrested for being drunk, paid a small fine this morning and was discharged. George Sellers, a former owner of a "soft drink parlor" in the Hatcher building, South Third avenue, that fell under official suspicion and was once searched for "boozie," was reported by the police to be in bed with a fractured rib and cuts and bruises about the head, face and body. He is the most seriously injured of the four combatants. It is said that a stranger here, who is accused of unheating a knife and "wadin" into the white men," is in jail, carrying numerous bruises. The third white man, said to be a hobo, whose name the police did not disclose, who is also in jail his coat buttoned and knapsack pulled down. It is reported to the police that the four had been drinking and that either becoming drunk, they got to "rowing," or the fight started over some dispute. Perhaps the spirit of the old south, which was personated all last week in a confederate uniform in front of the Odeon where "The Birth of a Nation" was showing, got into Folan's blood and got all stirred up, the white man, with whiskey. When the wrangling had continued about 30 yards the negro is charged with pulling a dirk and starting to cut his way out. He is accused of cutting Sellers, but the fractured rib Sellers carries is not so easily explained. The hobo's coat was slashed in four places across the back, but he didn't get into Folan's. The hobo's face is decorated with cuts and bruises, so is the negro's. Weinand was only slightly injured. Chief of Police Breckel and Officer Hurd, who was on duty in the depot district, gave chase. The former caught Folan near the old pottery plant. The hobo, who called the police, was also arrested in the depot district, and Weinand was found hiding in a bunk car in the Northwestern yards. Mrs. Neuroth was a member of the Catholic church. She is survived by her husband and nine children. 
