## COUNCIL ORDERS IN REST OF PAVEMENT

STARTS REMAINDER OF PROJECT BY ORDERING DISTRICTS AND STREETS IMPROVED.

BIDS TO BE OPENED ON MONDAY, JUNE 26

Contract Will Specify That Work Must Be Begun July 1 and Finished Oct. 25—Specifications as Regards Width of Pavement Remain Unchanged Since Last Revised.

Overruling all objections the city council, at an adjourned meeting this forenoon, ordered paved the four remaining districts of main roads to the city limits, and about three-quarters of a mile of city streets. The pavement ordered laid was for District No. 3, Summit street from Thirteenth west; No. 4, North Center street, from First street to the river bridge, and North Third street from the end of the pavement to Center street; No. 5, South Center street from the North-western right-of-way to the city limits south of South street; No. 6, North Third avenue from Marion street to the city limits, and Riverside street from Second to Third avenue.

The inside pavement is for North Twelfth street, from Main to State; South Twelfth street from Boone to Doty, except 200 feet just north and 200 feet just south of the M. & St. L. right-of-way, and North Ninth street from State to Summit.

Open Bids June 26. The council will receive bids for all four districts and the inside streets Monday, June 26, at 9 o'clock. The resolution specifies that the work is to be begun by July 1, and finished by Oct. 25. Each bidder must file with his bid a certified check for \$1,500 for each district, and the inside streets, a total of \$7,500 for the entire project. The specifications remain as they were prepared for the hearings on objections. North Center and North Third streets, North and South Twelfth, and North Ninth street are to be thirty feet wide. Summit street is to be twelve feet wide on both sides of the seven-foot strip for the street car tracks.

Center Street Unchanged. Although some of the South Center street property owners wanted the pavement widened to twenty-four feet all the way, the widths were not changed.

This pavement remains twenty-four feet wide from the Northwestern right-of-way to Washington street; sixteen feet from Washington street to the Linn creek bridge; twenty-four feet wide from the bridge to South street, and sixteen feet from South street to the city limits.

The seven-foot strip on Summit street west of Thirteenth in which the street car line may be laid, at some time will be filled with gravel and clay binder. The north side of the street along the soldiers' home grounds will not be paved this year, or until the state appropriates money for the improvement.

North Third Avenue. The resolution for paving North Center street provides for pavement only to the bridge, but it is the intention of the city to gravel the road north of the bridge to the city limits. With wide parkings in the center, and ample drives on both sides, the North Third avenue project will transform sandy wastes in Riverside street and the avenue north of Marion street into a beautiful boulevard.

The drives on both sides of the parkings will be connected at intervals with wide intersections. The drive-ways in North Third avenue, from

Marion to Riverside street, will be twenty feet wide; from Riverside to the north end of the parkings they will be twenty-four feet in width, and in Riverside street from Second to Third avenue, they will be twenty-five feet wide. From the north end of the parkings to the city limits the pavement is to be sixteen feet wide.

The specifications for the pavement are gravel with clay binder, and five inches thick in the center, and five inches thick at the edges. Concrete curbing will be laid around the parkings and along the outside of the drives. All of the other paving of these four districts and the inside streets is of one-mix concrete six inches thick.

WORK ON PAVING BEGUN.

First Curbing For Street Improvement Being Laid.

Actual work of laying pavement and curbing on the center of the contract was begun this morning in North Third avenue at Lincoln street. Adolph Carlson, who has the sub-contract for the curbing, began there this morning to pour concrete into the forms for the curbing.

DIES AT SOLDIERS' HOME.

Mrs. Sylvia H. Post, Member From This City, Passes Away.

Sylvia H. Post, who was admitted to the soldiers' home July 27, 1915, from this city, died at the home hospital Wednesday evening at 9 o'clock from shock, following an abdominal operation. Mrs. Post was born in Trumbull county, Ohio, Jan. 28, 1846. Her first husband, John Stewart, thru whose record she entered the home, served in Company H, Twenty-third Iowa Infantry. She is survived by two brothers and one sister, Albert Mills, of Fort Wayne, Ind.; John E. Mills, of Columbia Falls, Mont.; and Mrs. Jennie Stewart, 1704 Summit street, this city.

The funeral will be held from the Central Church of Christ Friday afternoon at 3 o'clock, interment following in Riverside.

Large Farm Deal Closed.

A large and interesting transaction in farm land near Albion, that was negotiated last winter, has been closed by the transfer of the 280-acre D. D. Springer farm. A. S. Bery is the pur-

chaser, and the price was \$63,000, which is at the rate of \$228 an acre. The purchaser assumes an \$8,000 5 per cent mortgage and gave back a purchase price mortgage for \$52,000, bearing 6 per cent and running for five years. The land is a fine piece of property and lies about half a mile west of Albion.

In the Police Court.
