After searching for two days, first for his injured wife, later her body and child, and causing the police, newspaper men and sympathetic friends all sorts of trouble trying to find the injured, dead woman and child, the man who caused all this inquiry and search was arrested Tuesday night by the police. It is believed by the police that the man is insane. Who he is has not yet been determined. He had nothing on his clothes to identify him. He said his name was Fred Clark when Officer Deahoyde took him in custody. Earlier, while instituting the search he said his name was Lawrence Winebeck, of Silvis, Ill. Later he said his name was H. A. Stevens, 224 South Center street. (There is no such address.)
Monday he appeared at police headquarters, and said that he was Lawrence Winebeck. The story he told was in effect that he was a brakeman on the Rock Island, running out of Des Moines. Sunday night, just as he was ready to go out on his run, he said the conductor of his train handed him a telegram from this city that his wife had been seriously burned. Winebeck came here searching for his wife. He had lost the telegram, he said, and could not remember who had sent it.
The newspaper heard of the supposed accident thru another inquiry, but could not find the woman.
"I'm H. A. Stevens, 224 South Center street," he announced.
"I want to have a card of thanks printed," he went on. "A friend of mine has lost his wife."
"You knew she was dead didn't you?" Burned to death."
"Yes, she died at 2:30 yesterday afternoon. At 6:30 yesterday morning she went to turn off the gasoline stove at my home, and by mistake she turned it on. The flames spurted outside the stove and caught her dress. My wife, who has been sick, threw water on her and put out the fire. They took her to St. Thomas hospital and Dr. A. B. Conaway took care of her, and the body is at Purcell's."
