AMES HOSPITAL DEDICATED.

More Than 2,000 Attend Ceremonies at Greeley Memorial.

Ames, Sept. 25.—Over 2,000 persons attended the dedicatory exercises held Sunday afternoon when the Mary Greeley Memorial hospital was officially turned over to the city of Ames.

The new institution, which is the gift of Capt. Wallace M. Greeley, in memory of his wife, Mary Greeley, was erected at a cost of \$80,000 and is equipped with the latest hospital appliances.

IOWA'S BEST CORN SHOW.

Exhibition at Cedar Falls Largest and of Highest Quality This Year. Special to Times-Republican.

Cedar Falls, Sept. 25.—The Cedar Valley District Fair here last week eclipsed all other fairs in Iowa to date, not excepting the Iowa state fair, in the extent and quality of its corn show, according to Prof. P. C. Taff, of Iowa State College, Ames, who judged the corn.

Most of the corn was grown in Black Hawk county, though some came from adjoining counties, and the major portion of the display was of the new strain developed by the Black Hawk County Farm Improvement Association, "Black Hawk County Reds."

The entire display of agricultural products was said to run the state fair a close second in volume and quality.

With 51,870 people passing thru the turnstiles during the week, the Cedar Valley fair set a new record for attendance in northwestern Iowa that should stand for some time.

CROSS COUNTRY RUN POPULAR.

Proving Most Popular Sport Among Athletes at Cornell.

Mount Vernon, Sept. 25.—In spite of the emphasis which is being put upon football, the most popular form of athletics at Cornell this fall is proving to be cross country running.

Seventy-five men are already taking the tri-weekly jog along the Mount Vernon road. Coach Pinger and trainer Mann are in charge of the work and the lines are being led by K. C. Smith, one of the Cornell men who placed at the state meet last spring, and Torrence, winner of the mile at last year's conference meet.

As yet the distances being covered are short but will be lengthened until the fall meet is held here a week before Thanksgiving. The winners of the first five places in the final will be awarded double C jerseys. Last year K. C. Smith came in first in the record breaking time of 25:25:13-5 for 4 1/2 miles.
