CAMPION IS DIRTY

HARDING PARTISANS IN DESPICATION THROWING MUD AT MEREDITH.

ATTEMPTS TO DEFAHE HIS PRIVATE CHARACTER

Lawyer Going About Trying to Incite Some One to Bring Suit Because of Ancient Idaho Land Deal—Governor of Western State Exonerates Meredith and Other Investors.

Special to Times-Republican. Des Moines, Oct. 4.—The present campaign for governor is going to be a dirty one.

Steve Barhor, third party progressive candidate for governor, predicted a week ago in his Des Moines speech that these things were to be done. He said that Harding had affidavits from saloonkeepers against Meredith's private habits and that members of the legislature were making affidavits that Harding had drunk liquor, although Harding has been telling chautauquists that he is a teetotaler.

The Homestead, which seems to be the journalistic scavenger in this campaign, printed a page or two of innuendo about Meredith's connection with Bro. Holden in an irrigated land deal in Idaho, but was very careful to explain that

"The Homestead does not charge that this wild, visionary scheme was evolved with any intent to defraud."

However, this land deal is constantly referred to in the "chain letter" and the insinuation repeated that there was something crooked about it, hence the desire to get somebody to start a suit about an old speculation.

It seems that Meredith invested with Holden in an irrigated land promotion expecting that the government was going to build irrigation works which did not materialize and the speculators lost money in this venture.

However, the land department of Idaho has given Meredith the following clean bill of health as to this deal: "State of Idaho, Governor's Office, Boise, Sept. 27, 1916.—Hon. E. T. Meredith, Des Moines, Iowa.—Dear Sir: I understand that the partisan press of your state is attacking your personal character in regard to your connection with the West End-Twin Falls Irrigation Company in the state of Idaho."

"Since my connection with the state land board, as chairman, your company has done what has been required of them, giving a new bond for the faithful performance of its contract in place of an old one which we believed to be obsolete and not valid in law. You have also spent money in rehabilitating the project so that the bona fide settlers can live upon the tract."

"Previous to my membership on the board, the attorney general, who was a member, informs me that you acted in good faith and put your own money into the project to protect contract holders, and it therefore gives me pleasure to write these few lines to you in order that you may protect yourself and satisfy your constituents that there is nothing in your connection with this project that reflects in any way on your integrity, honesty and good intentions. Yours very truly, M. Alexander, Governor."

Enormous Campaign Fund. An enormous campaign fund is on tap for Harding as evidenced by the chain letter system being used. The M. W. Fitz letter attacking Meredith's character is said to have been sent out in such quantities as to cost \$12,000. The Homestead has printed for the free use of Harding newspapers a supplement of four pages which will cost somebody \$5,000 to \$10,000 if used very generally by their friendly press.
