## TRIPLE SHOOTING BY WOMAN

Mrs. Carl U. Anderson Kills Stepson, Wounded Self and Husband.

WOMAN LIES IN COUNTY JAIL.

Tragedy was Result of Night's Quarrel and Later Agreement of Husband to Leave the State.

Kimballton, Ia., Sept. 2.—Following a night of quarrels and misunderstanding, ending in an agreement to separate from her husband, Mrs. Carl U. Anderson shot and killed a son of her husband, later fired the bed under which she hid the body, shot her husband, and then after walking a half mile turned the gun upon herself, inflicting a slight wound. Today the woman lies in the county jail at Audubon, waiting that she cared too much for husband to part from him, and that she thought it better that they all die together, the husband lies on a bed of pain at the home of a friend near town, while the blackened and almost unrecognizable remains of the son, Victor, lie in the morgue here.

Both Mr. and Mrs. Anderson will live, neither being seriously injured. They have been married four years. The boy is the son of a former marriage of Mr. Anderson.

The trouble between the husband and wife started Thursday night when Mr. Anderson attended a dance at the home of Claus Peterson, to which he refused to take his wife. He spent but a few minutes at the dance, indulged in a couple of dances and then left for home. The wife, in the meantime, furious at this conduct, left home and started for the dance on horseback. She arrived there after her husband had left and remained at the Peterson home until the early hours of the morning.

When she left she was escorted by a number of her friends, the avowed intention being to "get even" with the husband. A quarrel ensued, and someone called Sheriff H. Creel of Audubon. He went to the home and in a jangle, which lasted from 3 o'clock until long after daylight, an agreement was reached. Mrs. Anderson promised to leave the home for the day, the husband in the meantime taking his wagon and son and quitting the country.

Sheriff Creel accompanied the woman to town, to the home of Chris Nelson. Mr. Anderson followed to town a little later to wind up some business affairs before leaving the state as he had agreed to.

While he was still in town, and while the Nelson family were at breakfast, Mrs. Anderson returned to the home, and finding the 9-year-old son of Mr. Anderson in the home, shot him.

She then secreted the body of the boy beneath a bed in the upper chamber. A few minutes later her husband returned to the house and asked for the boy. The woman turned the gun upon him, and inflicted slight wounds. He started running towards Kimballton. Mrs. Anderson then went to the second story, fired the bed under which the body of the boy was secreted and also set fire to the furniture in the lower part of the house. She then walked a part of the way to town, turned the gun upon herself and inflicted slight flesh wounds.

Sheriff Creel was on the way to the home at the time, and after arresting the woman and placing her in the hands of medical attendants, he went to the house and helped in the attempt to rescue the body of the boy from the flames. The fire had gained great headway, however, and the body was badly burned. Mrs. Anderson was then taken to Audubon, where she was placed in jail.

Later in the day information was filed against her by County Attorney Hal Mantz. She is charged with the murder of the son and with assault with intent to kill upon the husband.

**Youth Hit by Freight.**  
Jefferson, Sept. 2.—Ralph Chaney, aged 18, was struck by a train on the Chicago & Northwestern at 4 o'clock this morning, and now lies at the point of death with a crushed skull.

Chaney was coming into Jefferson from the north when a special freight train, running at the rate

of sixty miles an hour, struck the buggy in which he was riding. Chaney was caught in the top of the buggy, which fell on the engine pilot, and was carried a distance of five blocks before the train men could stop the train and remove him. No hope is entertained for his recovery.

**Close Escape From Death.**

Mapleton, Sept. 2.—John Edgington, son of County Supervisor Edgington, one of Monona county's wealthiest farmers and stock feeders, narrowly escaped being killed last night while returning from a carnival at Charter Oak, Ia., in his automobile.

It is presumed that in turning out to pass a team a front wheel got into a deep rut in the road. The car turned over three times and is demolished, while Mr. Edgington sustained only slight scratches and bruises.

**In Peril of Fish Famine.**

Des Moines, Sept. 2.—State Game Warden George A. Lincoln holds that Iowa is in peril of a fish famine.

In his opinion bayous and inland lakes throughout the state are drying up to such an extent that fish are greatly affected. Mr. Lincoln states that few pickerel or pike will be turned loose in Iowa waters this year.

Game birds, he states, are on the increase, and there are more quail and prairie chickens in Iowa now than at any other time within the last eleven years.

**Find Their Parents Dead.**

Los Angeles, Cal., Sept. 2.—Dr. Walter Owen Ryan, said to have been a wealthy physician, formerly of Springfield, Ill., shot and killed his wife and then committed suicide at their home here yesterday.

Dr. Ryan shot his wife while the couple were at breakfast. Two young sons who were upstairs heard the shots and found the body of their mother in the hallway and their father bent over the breakfast table dead.

C. D. Ryan, one of the boys, told the police his father recently had shown signs of an unbalanced mind. His mother visited a lawyer yesterday for advice.

**Horses Burned; Owners at Fair.**

Nevada, Sept. 2.—Ten head of horses belonging to neighboring farmers were cremated in a fire here yesterday afternoon which destroyed the large Phifer feed shed covering a quarter block in the business portion of the city. The structure was a frame concern covered with iron and burned like a flash, being flat on the ground in less than half an hour. Mr. Phifer is out of the city and information as to his loss and insurance cannot be secured. The owners of the horses burned were in Des Moines at the fair. The shed was full of teams at the time but the majority of them were rescued.

**Woman Held by Her Hair.**

Atkinson, Ill., Sept. 2.—A lock of her hair catching in the belt of a motor engine of a washing machine, Mrs. Alfonso Ballert was lifted to the ceiling and held suspended there for several minutes. Her condition is critical.

**Explode Bomb at Dubuque.**

Dubuque, Sept. 2.—A dynamite bomb was exploded late Thursday night outside the establishment of George Mulholland. The detonation alarmed the city, but the damage was slight.

## STATE'S BEST FAIR OVER

Gates Closed Last Night on Exposition Successful in Every Respect.

THE RECEIPTS WERE LARGE

Estimated by Secretary Corey That Fair Has Netted \$40,000 Profit—Great Stock Parade.

Des Moines, Sept. 2.—The fifty-seventh annual state fair and exposition has passed into history. The formal closing took place last night, with the conclusion of the big hippodrome show in the stock pavilion.

The attendance yesterday was in the neighborhood of 15,000. On the same day last year it was 12,000. It was the first disagreeable day that the fair board has encountered since the exposition opened. It was hot and a high wind swept great clouds of dust over the grounds.

From every standpoint the fair has been the greatest ever held in this state. In one respect the fair has been the greatest ever held in the world. All authorities are agreed that the live stock show has never seen an equal.

In point of attendance the exposition has passed, the marks set by all previous years. Both on Tuesday and Wednesday the attendance broke the highest record set by any fair heretofore held. The Tuesday attendance was 62,000, and on Wednesday it was 59,000. The highest previous record was made on Wednesday of the 1909 exposition, when the attendance totaled 58,000.

In the matter of receipts the exposition was ahead from the start. Increased attendance, larger and better exhibits, caused the source of revenue to yield a larger sum than ever before realized.

Secretary Corey of the fair board estimates that when the final result is known, that the fair this year will net \$40,000 profit.

It is figured that the expense of the exposition will total practically \$150,000. This was reached Wednesday night and the receipts of Thursday and yesterday practically were all profit.

The premiums being paid to prize winners by the fair board this year are greater than ever before. The board started paying off the prizes yesterday morning. By tonight it is figured that fully \$30,000 will be given to the ribbon winners.

The exit of exhibitors and stock men began last night. The greater part of the exhibits will be removed from the grounds today, although it will take a week to get everything carted away. Most of the stock men are just starting out on their annual tour over the circuit of fairs.

But little was doing yesterday in the line of entertainment save the show before the grandstand in the afternoon and the hippodrome show at night in the stock pavilion.

The "million dollar" parade of live stock prize winners in the afternoon was the finest ever held. All the cattle and horses which won premiums in the judging the past week were paraded before the grandstand.

The Galt Killie band led both processions. They made a great appearance in their smart uniforms.

At the head of each parade rode President Cameron of the state fair board and state fair officials and state officers. Superintendent Pike of the cattle department was in the van of the cattle parade and Superintendent Curtis of the horse department rode in advance of the horse parade.

It is estimated that fully 500 cattle and as many horses were in each procession. The race course was filled for almost half its length.

The concessions and privileges at the fair have netted more money to the state fair board this year than ever before. Superintendent Brown stated yesterday afternoon that his department has had a revenue which amounts to almost \$25,000. This is \$4,000 more than any other fair ever secured from the Midway people.

The much advertised race between the aeroplanes and Ray Harroun and Steinhauer, the former in a Marmon and the latter in an Abbott-Detroit, were not pulled off as scheduled yesterday afternoon. Both Parmalee and Turpin were

in the air for a long time. They circled over the race course time and time again, but no signal was given them. After flights lasting fully twenty-five minutes both men alighted. They refused to go up again.

Harroun in his Marmon car waited on the track for the aeroplane to rise again but there was nothing doing.

The motor car feature amounted to a few exhibition spins around the course. Harroun made a two-mile dash, Heineman did a turn in a Case racer, Jay McNay slid around the curves in a Cutting car, and Steinhauer in an Abbott-Detroit gave a three-mile exhibition run. This concluded the programme.
