THE supreme court of Arkansas has sustained the law running all the foreign fire companies out of the State, and now only such local companies as are free from pools, combinations and agreement to fix prices can operate. Whether Arkansas can carry her own insurance under these restrictions remains to be seen, but the chances are that she will and save money for the insured. Two local companies are operating in Louisville and their success is phenomenal. It will be the same way in Arkansas. There ought not to be objections to foreign insurance companies doing business in any of the States, but that State is richer and more prosperous which is able to say that its local companies get the bulk of its insurance. The South sends a vast volume of wealth to the North each year in the shape of insurance premiums, and if Arkansas teaches the balance of Dixie how to keep this large sum at home, without injuring commerce, then the South will owe Arkansas a debt of gratitude. Fire and life insurance companies have extorted long enough on our people.

THE nomination of J. T. O'Neal, an ex-democrat, who had pledged his support to Paul C. Barth, the democratic nominee for mayor of Louisville, for mayor of that city on the republican ticket, does not set well with the rads, who are howling loud and long. The Louisville Herald, a Caleb Powers assassination organ of the deepest dye, is sore over the ticket made and disposes of the convention that nominated O'Neal as follows: "The convention was as farcical as its parents, the primary. The nominations are as farcical as either and the people will have none of it. A new Redwine, not of Breathitt, but of Jefferson, has made his appearance in the person of Alfred Selligman, and the republican convention of 1905 will go down to history as the rawest of the raw in Kentucky politics."

POLITICAL.

Elihu Root took the oath of office as secretary of State at Washington. He immediately took up the business of the office.

Negroes at Knoxville, Tenn., have not only boycotted the street cars because of the "Jim Crow" law, but have established hack lines.

Special envoys of the independent Norwegian Government are said to have been in the United States for some time with a view to "feeling out" the American State Department as to its disposition in regard to recognizing their Government.

In a letter to Mayor Weaver, of Philadelphia, Elihu Root advises the Mayor to inaugurate prosecutions against certain persons shown to be implicated in criminal practices connected with the manipulation of the city government for private profit.

Justice Warren B. Hooker took the witness stand in his own behalf in the impeachment proceedings before the New York Legislature. His statement consisted of a denial of any wrongdoing or knowledge of improper acts by others with whom he was associated.

Peter Vinegar, the Lexington Negro preacher who made considerable reputation preaching from the subject, "A Damned Hot Day," is dead.

Here and There.

Paul Mannini, a well-known resident of Danville, died of heart failure.

The City National Bank at Kansas City, Mo., failed to open its doors.

Edward Gottschalk, under sentence of death, hanged himself in the jail at St. Paul.

The Jews celebrate this year the 250th anniversary of their settlement in the United States.

Max Wolf, of Louisville, was arrested at North Vernon, Ind., while smoking a cigarette on a train.

On rumors of black rust in the Northwest, September wheat at Chicago jumped to 88c a bushel.

One man who held up and robbed five others in a drug store at Omaha, was caught after a lively street fight with pistols.

George Wright, city passenger and ticket agent of the Southern railway at Rome, Ga., was shot and killed by Vince T. Sanford.

William Cornett, of Garrard, sold to W. T. Robinson a pair of three-year-old mules for \$460 and a gelding to Ed Corithers for \$175.

Seventy-five deaths from heat prostration were reported in New York City. Showers and thunder storms brought relief and reduced the temperature to normal summer conditions.

Chairman Morton, of the Equitable, summarily dismissed Controller T. D. Jordan for refusing to furnish desired information, and appointed Assistant Attorney General William A. Day to the position.

It now seems certain that the Paris-Maysville electric line will be built, the subscription allotted to Paris, \$6,000, having been taken in a few hours. The proposed road will tap one of the most productive agricultural regions in the State.

J. B. Haggin, of Lexington, is helping the cause of education by employing on his big farm during the summer more than 200 college boys. If a youth is physically unable to labor in the fields he is given work suited to his strength.

Judge McElhinny, of the St. Louis Circuit Court, dissolved the receivership for the People's United States Bank and discharged the receiver. The court's ruling was based on the fact that Secretary of State Swanger had failed to make a personal investigation of the bank's affairs.

The State Board of Valuation and Assessment took action on several corporations in the matter of valuation for franchise tax purposes. There was an appreciable increase all along the line. The Louisville Bridge Co.'s valuation was fixed at \$1,755,000, being an increase of \$55,000 over the previous year.

Union Station, the fine passenger depot in Louisville of the Louisville & Nashville Railroad, was destroyed by fire Monday night, entailing a loss of at least \$200,000, and valuable records for 20 years. The flames were discovered shortly before 10 o'clock, but the effort to extinguish them was unavailing. The station was erected 15 years ago, and had been used by the Louisville & Nashville Railroad as its main passenger station in Louisville since 1891. The structure was practically gutted, although almost entirely built of stone, and some of the walls collapsed.

IN NEIGHBORING COUNTIES.

James Lucy, aged 54, is dead at East Bernstadt.

Miss Sadie Brasheer died of tuberculosis at Middlesboro.

Judge J. W. Butler, who was one of Adair county's most prominent citizens, is dead.

Andrew Wesley, of Eubanks, had a leg cut off while attempting to get on a freight train.

P. Bleavens Lay shot and killed Garfield Sevier in Cumberland county, alleging self-defense.

Nancy Carpenter, 14 years old and one of a party of merrymakers, was drowned in Kentucky river at Valley View.

County Judge Ben V. Smith, of Somerset, has refused to recommend the organization of a State guard company because the fiscal court will not build an armory.

The pleasure boat "The Shamrock," when three miles above Valley View, on the Kentucky river, struck a steel guy line which tore off the pilot house of the boat and swept more than half a dozen of the 50 passengers into the stream. One girl was drowned and two other persons badly injured.

CHURCH MATTERS.

The Baptist General Association minutes have been printed and show that the 199,888 white Baptists in Kentucky gave last year \$480,043.65.

There will be quarterly meeting services at the Moreland Methodist church next Saturday and Sunday, with Presiding Elder J. W. Simpson officiating. Be sure to attend.

The meeting at the Church of Christ continues with considerable interest. Rev. R. H. Boll, of Louisville, is pronounced by good judges to be a splendid expounder of gospel truths.

Although Cumberland Presbyterians had no increase in membership from 1902 to 1905 their gifts to foreign missions increased from \$40,791 to \$52,686, a gain of 33 per cent. Gifts to ministerial relief increased 66 per cent.

John Franklin, who claims to be a Methodist preacher with his residence in Big Sandy county, West Virginia, was before Judge J. J. Riley yesterday morning on the charge of drunkenness and carrying concealed weapons. The Rev. Mr. Franklin made the remarkable statement that he had spent \$5,000 in cash during the last year for whisky, but has sworn off never to drink again.—Lexington Herald.

The Agricultural and Mechanical (State College) of Kentucky offers the following courses of study, viz: Agricultural, Horticultural, Chemical, Biological, Mathematical, Physical, Normal School, Classical, Mechanical Engineering, Electrical Engineering, Civil Engineering, and Mining Engineering, each of which extends over four years and leads to a degree.
