BIG LUMBER CONCERN.
Organized in Mexico Which is Backed by Joe Choate.

Mexico City, Dec. 10.—For the purpose of furnishing lumber to the United States and European markets, the latter by a line of steamers which will be operated around Cape Horn, a large company, said to be backed by Joseph Choate, former United States ambassador to England, has been formed with American capital and has already started operations in the state of Colima. They claim to have a supply of from 20,000,000 to 30,000,000 hardwood ties that will be shipped both to the United States and Europe.
