### 25 YEARS FOR CARTER.

Ed Carter who resided in this city until last fall when he left his wife and went to New Madrid, Mo., is up against the real thing now. He had been there only a short time when he killed a man while on a drunken spree. For this offense he gets 25 years in the penitentiary at Jefferson City, Mo.

Speaking of the case, the Record says:

Ed Carter was tried Tuesday on the charge of murder for killing Charles Hand, the Farrenburg mill man, H. C. Riley, Jr., representing the state and C. C. Collins and Robert S. Rutledge the defendant. The testimony was about the same as given at the coroner's inquest and published in the Record, that the men were intoxicated at Kendall's saloon, Hand refused to treat, and was followed out of the back door by Carter who stabbed him to death. The case was warmly contested and the jury gave Carter 25 years in the penitentiary.

### FORMERLY OF HICKMAN.

J. T. Dillon, secretary of Fulton Lodge No. 83, I. O. O. F., received a telegram last Friday morning that John Cochran had died at Melrose, N. M. Mr. Cochran was a member of the Odd Fellows here, but having no relatives here the local lodge wired them to give him a respectable burial and draw on them for the cost of same.

Upon inquiry, we learn that Mr. Cochran had been sick at Pauls Valley, Okla., and that this lodge had lent him assistance.

### MUST SPRAY TREES.

Isaac Shuff, one of the most successful fruit raisers of Fulton county, has demonstrated that it has become necessary to spray trees if fruit is successfully grown. Conditions have so changed in the past few years that the crop is almost a failure, although Fulton county orchards were once the most abundant producers in the state. Mr. Shuff seems to have solved the problem in a great measure by spraying his trees. He not only gets a good yield since he inaugurated this policy but the quality of the fruit is much better. Other fruit growers might profit by his experience.
