

DEATH ROBS PRISON OF
MAN JUST CONVICTED

Wilmington, Del.—Charles S. Miller was stricken with heart disease at the Newcastle county workhouse and died in a few minutes.

Miller was joint defendant with Raymond McCune on the charge of using the mails to defraud in connection with the Peruvian Exploration company, the Peru Gold Placers company, and the Maranon River Placers company. Both men had been found guilty after a trial which lasted over three weeks.

Counsel for the men made a motion for a new trial, but the plea was withdrawn and McCune was sentenced to pay \$1,000 fine and be imprisoned for four years at Atlanta, and Miller sentenced to pay \$1,000 fine and be imprisoned for three years.

The jury, which had been out all night, in returning their verdict recommended Miller to the mercy of the court. Former Judge J. Frank Bell, who represented Miller, called the attention of the court to the fact that he was in ill health and Judge Edward G. Bradford, in passing sentence, said there was a way to reach that matter, evidently inferring that his condition could be made a subject for clemency.

Miller took his sentence quite coolly, but was taken ill later in the marshal's office. He recovered sufficiently to be taken to the workhouse, but on reaching the warden's office he collapsed again and died.

Boasts Before Marriage—Suicides Because He Cannot Make Good.

Bozeman, Jan. 9.—Because he could not make good his boasts made during his courtship regarding the value of his property, Josiah H. Fuller, a groom of two days, killed himself, according to disclosures made yesterday. A test of the man's stomach was made by Edmund Burke, a chemist. The test revealed the presence of strychnine. The deceased's bride was Mrs. Cora George. Fuller was violently in love with his wife and to attract her before marriage made claims of wealth he did not possess. Before taking the poison Fuller wrote a long letter to his bride. That has never been published.

BOY A SUICIDE.

Kalspell, Jan. 9.—For trivial reasons, Mikie Julian, an Italian boy, 20 years old, shot and killed himself here yesterday. Julian was called to go to work yesterday morning. He was expected to join a section crew. A few minutes later a shot was heard and when his friends reached his side the boy was dead.


