# TEACHERS WILL MEET TOMORROW

Action Will Be Taken on Proposed Substitute Bill for Pensions.

Tomorrow (Wednesday) afternoon the teachers of Butte will meet at 4:30 o'clock at the new high school auditorium to investigate the terms of the proposed substitute teachers' pension and annuity bill, and if the measure is approved they will appoint a committee to lobby in Helena for the measure.

As has been explained before, the present teachers' pension fund cannot be handled effectively. Sufficient appropriation has not been made to render the measure practicable. It called for a pension of \$600 a year at the end of 25 years' service, and the teachers availing of the pension fund system were expected to pay \$1 a month into the pension treasury.

The contemplated substitute for the bill provides a pension of \$300 a year after a service of 30 years and an annuity, the amount of which will be graded by the amount of money paid in to the fund by the teachers. The \$300 pension will be furnished from a fund created by a tax of one-tenth of a mill on the entire state. It is said the teachers propose paying \$35 a year into the annuity fund.

The teachers have been carefully considering the measure for the past few weeks and are all well acquainted with the terms of the bill. It is understood that the Butte teachers will pledge their support to the new measure. The Silver Bow delegation, it has been learned, is solid behind the wishes of the teachers in this matter and no serious objection is anticipated to the bill or to the appropriations which it carries.

Last week Miss Julia Shea, the county superintendent of schools, and Miss C. O'Donnell attended a meeting of the teachers' committee from various parts of the state and discussed the measure and canvassed the situation. These ladies will, in all probability, address the meeting tomorrow afternoon. It is expected that every teacher in the county of Silver Bow will be present at the meeting, which is of so much importance.

# TO PLACE BAN ON THE DANCE HALLS

Mayor Orders Chief of Police to See That Regulations Are Enforced.

"And when Ethel gets big keep her away from dances."

This abstract from the note written by Bernard T. Murray, shortly before he killed his wife and himself, as a message from the dead, will do its good in Butte. Cheap dance halls may be closed, as Mayor Lane this morning demanded of the chief of police that strict regulations be imposed. The mayor insists that the police protect the "Ethels" in Butte and prevent such tragedies as happened last night, sending a man guilty of murder before his Maker and a woman, possibly equally guilty, before the Great Judge.

"No 'Ethels' in Butte will be exposed in cheap dance halls if police regulations can prevent," said the mayor. "I have been informed that the dance halls here are being conducted in a proper manner. If this is not true, the evil will be corrected."

"This is where I have lost out," is another excerpt from the dead man's letter, referring to dance halls, which he blames as the cause of the troubles between himself and his wife.

"There are good dance halls and bad," said the mayor. "There are places where young men and women may go for an evening's enjoyment where there are no temptations, only innocent pleasure. But there are other places where beasts, under the name of men, congregate ready to prey upon the young girl who knows no better. I hope there are no such places in Butte, but if there are, and the police will find them, they will be stamped out with the same relentlessness with which a man steps his heel on the head of a rattlesnake."

of stock at \$20 a share, inasmuch as it had been increased without prior notice to them of the increase. The letter said the stock could be purchased at \$20 on a cash basis or on easy terms as low as 10 per cent cash and the balance in monthly, quarterly or semi-annual payments, having as long as one year for the payment of the same.

Simultaneous with the conviction of Sidebotham and Wilmot came acquittal of five other defendants of the company, former officers. Those acquitted were A. M. Alderson, former secretary of state; William C. Rae, former state treasurer; J. W. Spear of Great Falls; D. G. Bertoglio of Menderville and Miss M. A. Cort, a former assistant secretary of the company.

Three other former stock salesmen originally indicted were acquitted by directed verdict before the trial was concluded. The indictment against another, J. A. Sampson, was dismissed before the trial started. Four of the defendants named in the original indictment were not apprehended.

Public Administrator T. J. Harrington has filed a petition with the clerk of the district court asking for letters of administration in the matter of the estate of James Hendry. The value of the estate is unknown and consists principally of a cause of action against the Northern Pacific Railroad company for personal injuries.
