HAVRE HUMBLER BY HELENA TEAM

Gallatin Disposes of Forsyth. Butte Rumps Home at the Bozeman Meeting.

Bozeman, March 8.—Helena, three state champions, ambled into action this morning by disposing of Havre in a somewhat listless game, score 27 to 18. Metien scored 15 of his team's 27 points. Havre showed flashes of individual form and the work of Goff, the colored guard, attracted attention. Gallatin advanced a notch in the second game of the morning by defeating the heavier Forsyth team 28 to 19.

Anaconda Takes One.

Anaconda won the first game of the intercollegiate basketball tournament from Miles City last night by the score of 18 to 17 in a fast and snappy contest. The Custer county squad was ahead 7 to 5 at the close of the first half, but by the defensive work of Thorson and Scullon the lead was held down. The game was not decided until an extra five minute period had been played.

Butte's Victory.

Butte easily won its game from Libby 21 to 2 without the assistance of Captain Myers, center. Fisher, playing in his position, worked good and the Purple and White had no difficulty in outclassing the western players. Crowley started in the game making 21 points, several of them from the center of the floor. Harris scored the one basket for Libby.

Butte's lineup follows: Crowley and Driscoll, forwards; Fisher, center; Sullivan and Zundel, guards.

The surprise of the first series of the state games was the defeat of Billings last night by Broadwater, whose players won 25 to 20. Coach Romney's men could not find their stride and were outclassed in their teamwork by the Broadwater squad. W. McDonald scored 12 points for Billings. Gabbert, Billings' fast forward, did not make a basket.

Washington, March 8.—President Wilson, who is suffering from a cold taken a week ago and made worse during his inauguration Monday, remained in bed today by order of his physician, Dr. Cary T. Grayson. No engagements were made by the president, and he will rest as much as possible during the next few days. Dr. Grayson said at noon that the president's temperature was above normal and that absolute rest for several days was necessary. The president spent a quiet night. The prospects were that Mr. Wilson would have to remain in bed for several days, although his condition was not serious.

Rotary Club Tenders Congratulations on Successful District Convention.

The Butte Rotary club at the weekly luncheon at the Butte Grill at noon today extended congratulations to D. E. Wilder, the city passenger and ticket agent of the Great Northern, for his attention, services and courtesies during the trip to Great Falls to the annual district convention. Thanks were extended also to the transportation committee. Compliments were given by the visiting members to the activities of the Rotary club in securing the passage of House Bill No. 167, the new highway law under which the county attorneys of the counties are empowered to prosecute traffic infractions. As each city is supposed to perfect its own traffic ordinance, a committee from the Rotary club will meet Monday afternoon at 2 o'clock at the Silver Bow club to prepare a suggested form of ordinance. J. E. Roche of the Montana Power company is the chairman of the committee.

Nevin should be the direct representative of the Butte club in the stunts which will be carried off. The governor of the district believed that all the clubs in the district should unite to send a district delegation to Atlanta.

A communication was received from the Spokane club suggesting that Montana and Idaho should be included in the fifteenth district, of which Spokane is the hub. This matter will be taken up at a later meeting.
