DEATH OF QUIRK TAKES A PIONEER

In Butte in 1863, the Black Hills and on Custer's Battlefield.

With the death of James Quirk in Gold Hill, Nev., Feb. 28, the west lost another of the pioneers and one of its most picturesque characters. Quirk was among the first to prospect for gold in Silver Bow creek, was a familiar figure in the early day camps of the Black Hills in South Dakota and for 14 years was sheriff of Storey county, Nevada.

James Quirk was born in Lasalle county, Illinois, in 1843, and at the age of 20 left that state for Montana. He was one of the first to prospect for gold in Alder gulch, where Virginia City now stands, and in 1876 went to Black Hills on a similar mission.

He went to Virginia City, Nev., in the early days also and won prominence there upon his ability at mine management. He was connected for years in a supervisory capacity with the development of the Yellow Jacket mine at Goldhill, which was one of the big producers of the early days, and did much to make the Nevada gold fields famous. He started at the mine as a shiftboss and was later foreman under the late Superintendent James H. Kinkead.

In 1892 he was elected sheriff and assessor of Storey county, Nevada, and held the office for 14 years. He was affiliated for years with the Ancient Order of United Workmen and with the Elks. As well as his nephew, J. A. Quirk of Butte, he is survived by his son, Frank Quirk of Goldhill, Nev.
