

SHOOTS BROTHER PLAYING SOLDIER

"I Didn't Know the Gun Was Loaded," Sobs Boy After the Accident.

Imbued with the spirit of preparedness which discussion of the recent turn in international events has stimulated, 13-year-old Arthur Forbes, son of Mr. and Mrs. Jack Forbes, was playing with his 6-year-old brother, Earl, at the family home, 244 Anaconda road, last night, when with a laugh he raised a .22-caliber rifle belonging to his father and fired a bullet through his little brother's heart. "I didn't know it was loaded," he sobbed a few minutes later when he was told that Earl was dead. "We were playing and I didn't mean to hurt him." The boy became so hysterical after the shooting that he was removed to the industrial school to be cared for.

The two brothers were playing soldier in the absence of their parents. Arthur had seized his father's rifle, which was left standing in a corner. He pointed it at his little brother, "Just like soldiers do," as he described it afterwards, and pulled the trigger. "I thought the gun was empty, and that it would be all right to play with it," he told neighbors who were attracted to the house by the shooting. When I heard the shot I didn't know what happened. I tried to tell Earl that it was all right; that I was just playing and didn't mean to hurt him, but he laid there so still and quiet and I knew something was wrong. I couldn't believe it when they told me he was dead."

A physician was summoned by neighbors, but upon his arrival he said that death had been almost instantaneous. Deputy Sheriff Jack Murphy was called and he in turn summoned the coroner. The body was removed to the Sherman & Reed establishment. Coroner Lane will hold an inquest Wednesday afternoon at 2 o'clock.

TALKS HERSELF INTO THE JAIL

Woman Refuses to Keep Quiet When Court Orders—She is Given 20 Days.

JUDGE LYNCH SETS MANY CIVIL CASES

He Announces Findings Before Making Second Call of Trial Calendar.

Judge J. J. Lynch held his usual weekly law and motion calendar today. GIRL BRINGS SUIT FOR \$25,000 FOR BEATING

Violet Buddle Claims She Was Whipped by Employes of Industrial School.

Violet Buddle, by her guardian, Annie Hazeltine, today brought suit for \$25,000 damages against A. C. Dorr and those employed about the state industrial school at Miles City, alleging cruel and inhuman treatment during the time she was an inmate of the institution. The suit has been brought by Attorney Wittenberg in behalf of the plaintiff.

It will be remembered that about a year ago Judge Doulan committed to the state industrial school the plaintiff until she attained the age of 21 years. On Feb. 19 of this year Attorney Wittenberg secured the release of the young girl on a writ of habeas corpus issued by Judge D. L. O'Hara.

The complaint filed with the clerk of the district court today it is alleged that on Feb. 12 Dorr and other employes of the state school took the plaintiff into a private bedroom and after removing the clothing from the lower part of the body, beat her with a strap to such an extent that she screamed from the pain. It is also alleged that for a time afterwards the girl could not sit down or lie on her back from the effects of the beating she received. The plaintiff asks for \$15,000 as damages and \$10,000 as exemplary damages.


