METAL TRADES TO DEAL WITH UNION

Executive Board Says Electricians Must Abide by Recent Decision.

on the hill irrespective of the price of copper. This was the original demand made by the Metal Trades council.

Seven dollars for electricians at work on shafts. This applies to men who are handling wires of high-potential voltage.

Double time for all overtime. All Sunday work to be classed as overtime, except change shifts or continuous operation work.

Complete abolition of the rustling card system, personal record and all similar systems.

The electrical workers on the hill as members of the Metal Trades council voted on the new metal trades crafts schedule during the past ten days, and while they rejected it, they are in duty bound to stand by the majority of the metal trades unions which voted to ratify the new schedule.

This was the stand taken at a meeting of the executive board of the Montana State Metal Trades council in the carpenter's hall this morning.

The officers of the council unanimously took the stand that the electricians must abide by the majority vote of the unions affiliated with the council.

"If the electricians refuse to stand by the majority and accept the schedule they will be kicked out of the Metal Trades council," declared one of the officers of the council in discussing the new situation.

The International Electrical Workers' union will also insist that the local union stand by the majority vote. If it fails to do so President McNulty will revoke the charter of the local organization.

Mr. McNulty made his position on this matter clear to the electricians before he left for the east.

If the electricians' union is put out of the Metal Trades council and has its charter revoked by the international it will be in the same position as the outlaws' miners' union. Should this action take place International Pres-

ident McNulty will grant a charter to another union in this city. The conservative electricians will then join this union, leaving only the radicals on strike.

That he does not consider the new situation of any consequence was evidenced by W. H. Rodgers, the federal mediator, last night, when he left for Minneapolis to assist in adjusting labor troubles there.

Somewhat more than 1,100 marchers took part in the funeral of William Kernan, a member of the local Metal Mine Workers' union, which took place yesterday afternoon.

At the grave a funeral service was conducted by Finnish women. The procession was orderly throughout.

Last night the outlaws' union held a mass meeting at the hall park, which was attended by 2,000. Tom Campbell, who presided, as usual, was bitter at the action of the hoisting engineers for approving the Metal Mine council schedule, and admitted that at the end of the seventh week the outlaws' miners are still alone, having received no recognition from organized labor.

At a meeting held by the outlaws' union in the lumber hall later at night Frank Little, the executive board member of the I. W. W., advocated direct action.

"LIMEYS" IS NICKNAME FOR BRITISH JACKIES

London, July 30.—American blue-jackets on duty in European waters have a nickname of their own for England's sailors and soldiers. They call them "limeys;" the individual being known as a "lime." The American sailor men apply the designation to all English fighters just as the British refer to their soldiers as "Tommys."

The sailor from the United States has his nickname for nearly everything he sees. Bluejackets who had served in the near far east first started calling British sailors and soldiers "lime-juicers" because of their fondness for fruit juice and charged water. Now the designation has been shortened down and everything British is "limey." British sailors and soldiers' clubs are known as "limey clubs" and British-brewed lager beer is commonly spoken of as "limey beer."

SEVEN CHARGED WITH KIDNAPING

Springfield, Mo., July 30.—The cases of seven persons charged with kidnaping conspiracy and brought here from St. Louis and Stockton, Mo., have been set for trial on the second Monday in August in Webster county, at Marshfield, Mo. The prisoners were brought here for a hearing on their request for a change of venue which was granted.

The prisoners were secretly brought here early today and closely guarded in the county jail while awaiting the hearing in the criminal court today of their application for a change of venue.

The prisoners are Claude J. Piersol, Taylor Adams and Cletus Adams, charged with the kidnaping of Baby Lloyd Keet; Dick Carter and Sam McGinnis, accused of attempting to kidnap C. A. Clement, a jeweler here, all of whom were brought from St. Louis. Mrs. Ailie Adams and Maxie Adams, also accused in the Clement case, were brought here from Stockton, Mo.

County Board Expects to Call One-third by Friday at Least.

The county outside of the city of Butte. Among the first 1,000 numbers on the master lists, there are but 674 corresponding serial numbers held by men within the jurisdiction of the county board. The board's first action this morning was the scratching out of all numbers not duplicated in the county. The first number in the master lists is serial number 258. The last of the 10,000 numbers is number 5,794.

It is pointed out by the board members that claim for exemption on the registration card is not to be construed as a presentation of claim for exemption. Three affidavits must be filed out after examination is claimed before the local board at the time of examination. On registration day, many registrars were instructed not to ask the question concerning an exemption claim. Hence, the presence or absence of a claim for exemption on June 5 will have no weight in the claiming of exemption before the local board.






