EXPECT ACTION SOON IN CASES OF THE I. W. W.

Much Evidence Secured in the Raids—Indictments in Short Time.

Washington, Sept. 11.—Progress of the grand jury investigation at Chicago into the I. W. W., whose offices were recently raided throughout the country, indicates that revelations of a nature not previously disclosed are being brought to light.

Reports to the department of justice from Frank K. Nebeker of Salt Lake City and Frank C. Dailey of Indianapolis, who are assisting District Attorney Clyne in conducting the investigation, are to the effect, it was said today, that "satisfactory progress is being made."

Indications point more strongly than ever, it was said, to the conclusion that a small coterie of men directed the entire anti-war activities and program throughout the country which had as phases the destruction of property, resistance to the draft law, the spread of alleged seditious utterances, publications and other mediums and other numerous methods intended to embarrass the government.

Indictments, it was said today, may be handed down within a short time.

ORGANIZATION WAS TO FORM A DEFENSE FUND

Chicago, Sept. 11.—Investigation of books of the I. W. W., seized in recent federal raids discloses that the organization's funds are too low to pay for the defense of members arrested for anti-government plots, it was learned today.

The records are said to show that the organization at the time of the seizure planned to levy a heavy special assessment to pay court costs. Federal agents are trying to learn how much of the levy was made, if any, and who were the important contributors.

Investigation of the books is almost complete. As fast as the examiners finish with them the books are sealed and boxed for production in court.

KORNILOFF'S MEN MARCH ON CAPITAL

Kerensky Takes Steps to Protect Petrograd From Seizure.

(Continued from Page One.)

and representatives of the Council of Workmen and Soldiers' delegates. General Korniloff's "Silkaya" division, which was formerly stationed at Pskoff and consists of Georgians and other Caucasus tribesmen, is reported to have occupied Witeza or Little Vyrazn on the Petrograd-Rybinsky railway, 54 versts from Petrograd.

RETREATING ARMY LEAVES AN APPEAL TO GERMANS

Petrograd, Sept. 11.—The committee of the Twelfth Russian army, before leaving Riga, left an appeal printed in German, and addressed to the German soldiers, pointing out that the latter were making war on the side of autocracy and against a revolution of liberty and justice. The appeal said:

"A victory of Kaiser Wilhelm would mean the end of democracy and liberty. We are leaving Riga, but we know the revolutionary spirit will prove stronger than your cannon; we know that in the end your conscience will see more clearly and that you will march on to victory and liberty, side by side with the revolutionary army."

"Your strength is greater than ours, but your superiority is merely of physical and material force. More force is on our side. History will relate that the German proletariat marched against their Russian brothers, forgetting the dictates of international solidarity."

OUTLOOK DARK IS THE VIEW TAKEN IN ENGLAND

London, Sept. 11.—The Russian crisis overshadows all else in the news and editorial columns of the morning newspapers. "Germany may enjoy the satisfaction of knowing," declares the Post, "that her sinister intrigues have produced a cataclysm in the revolution, which in whatever its results may consist must, as we continue to believe, ultimately destroy and eradicate German predominance in Russia."

The Times says the outlook is dark and that it affects the war on every front, "for the allies begin to realize that even in the most favorable circumstances the revival of the Russian military efficiency is bound to be remote."

The Times declares that General Korniloff is not a traitor, and says that if his ultimatum to the Petrograd authorities on Saturday was tantamount to dictatorship, it was evidently because he felt there was no alternative left.

The Chronicle says it is obvious that General Korniloff "would scarcely put a pistol at the government's head on Saturday unless he believed he could fire it," and adds that "the immediate future should show whether he can."

ministers on both sides. Following the ultimatum of General Korniloff, the whole Russian cabinet resigned to give Premier Kerensky full liberty of action. All the ministers for the time being will remain in their offices.

Eighty Arrests Made.

General Korniloff, in addition to refusing to abandon his command, ordered the arrest of M. Philonisko, the government commissioner. The provisional government, besides arresting Vladimir N. Lvoff, who brought Korniloff's ultimatum to the provisional government, took into custody 80 other persons.

The newspaper Ishvestia announces that the constitutional democratic ministers relinquished their portfolios on the ground that the Korniloff affair was one for decision by the entire cabinet and not by a directorate. Trouble for the Kerensky government is threatened also by the Maximalists.

At yesterday's sitting of the Council of Soldiers and Workmen's delegates they again urged that all power should pass into the hands of the socialists. It was resolved at the meeting, however, that Premier Kerensky should be supported unconditionally.

Monday night the capital was quiet and traffic was normal.

New Military Governor.

General Savonkoff has taken over the office of military governor of Petrograd in place of General Vasilkovsky, resigned. General Savonkoff has addressed a reassuring proclamation to the population stating that all necessary measures were being taken for the defense of the fatherland and of freedom.

Commander on the Riga front, has not yet been commissioned chief of all the armies of Russia, which post was refused by General Lokomsky, on account of the impossibility of Klombovsky reaching grand headquarters.

Kerensky's Plan.

Explaining to the council of soldiers and workmen Premier Kerensky's reasons for desiring the appointment of a directory, M. Skobeieff, the minister of labor, said the provisional government was incapable of dealing with the situation, as some of its members were Germanophile and at an hour when the country was threatened with disaster the premier believed it necessary to take the power into his own hands and get rid of the present government.

The arrest of certain persons, including Vladimir Purishkevich, a well known reactionary under the old regime, is expected.

No particular animation was noticeable yesterday until the evening, when the evening newspapers made their appearance and were eagerly brought up.
