

ALIAS SUMMONS

In the District Court of the Second Judicial District of the State of Montana, in and for the County of Silver Bow, Marjorie Christenson, plaintiff, vs. Roy Christenson, defendant.

The State of Montana sends greeting to the above named defendant: You are hereby summoned to answer the complaint in this action which is filed in the office of the clerk of this court, a copy of which is herewith served upon you, and to file your answer and serve a copy thereof upon the plaintiff's attorney within twenty days after the service of this summons, exclusive of the day of filing, and in case of your failure to appear or answer, judgment will be taken against you by default, for the relief demanded in the complaint.

1. That the plaintiff and defendant intermarried at Butte, Montana, April 29, 1916, and are now and ever since have been husband and wife.

2. That for more than one year last immediately preceding the commencement of this action the plaintiff has been and now is a bona fide resident of the state of Montana.

3. That the defendant disregarding the solemnity of his marriage vows has for more than one year last past willfully and without cause deserted the plaintiff and voluntarily separated himself from the plaintiff, and still continues to do so willfully and without cause, and has abandoned the plaintiff and voluntarily live separate and apart from her against her will, and without her consent; that said desertion and abandonment and separation have taken place in the county of Silver Bow, state of Montana, and commenced June 1, 1916.

4. That there are no children to said marriage and that plaintiff's maiden name is Marjorie Gleason.

Wherefore, plaintiff prays judgment that defendant for a decree dissolving the bonds of matrimony heretofore existing between plaintiff and defendant; that plaintiff's maiden name, Marjorie Gleason, be returned to her and for all other relief in the premises.

And for a further and second cause of action plaintiff alleges:

1. That plaintiff and defendant intermarried at Butte, Montana, April 29, 1916, and are now and ever since have been husband and wife.

2. That for more than one year last past and immediately preceding the commencement of this action the plaintiff has been and now is a bona fide resident of the state of Montana.

3. That the defendant disregarding the solemnity of his marriage vows has for more than one year last past willfully and without cause deserted the plaintiff, and voluntarily separated himself from the plaintiff, and still fails to contribute to the support and maintenance of the plaintiff, but has left plaintiff penniless and destitute, and plaintiff has been forced to earn her own livelihood.

4. That there are no children to said marriage and that plaintiff's maiden name is Marjorie Gleason.

Wherefore, plaintiff prays judgment against defendant for a decree dissolving the bonds of matrimony heretofore existing between plaintiff and defendant, and that the plaintiff's maiden name, Marjorie Gleason, be returned to her, and for all other relief in the premises.
