Is situated on the National Park Railroad, twenty-eight miles from Livingston and about the same distance from the National Park. At this point the Northern Pacific Railroad company are building a Depot, Section House, Water-Tank, Etc., and many other substantial improvements are going on. MONTANA NEWS.

Sleighs were on the streets in Helena yesterday.

The school election in Billings to vote a special tax of \$1,500 was carried.

Wells, Fargo & Co., have filed papers with the recorder to do business in Yellowstone county.

The owners of the Massachusetts mine at Neihart, refuse to rebond their property at \$15,000.

Merriam, republican, and McSorley, democrat, will represent Jefferson county in the constitutional convention.

A new paper is to be started at Sun River. It will be in charge of Marshal Wheeler, better known as the Commodore.

White Sulphur Springs is getting to be a pretty lively place. They had a prize fight and a horse race there one day last week.

The artesian drill in the well at Billings is now working through a limestone boulder formation 775 feet below the surface.

C. W. Savage, with 449 votes; W. Van Gasken, 292; S. R. Douglas, 281; will represent Custer at the constitutional convention.

Gallagher's surveying party which worked in the Musselshell country during the summer, has disbanded and gone east.

The entire force of the Montana Historical company's employees are now in Butte gathering data for the work to be issued next spring.

The men arrested at Park City a few days ago on the charge of horse stealing at Peace Bottom, have been discharged, it clearly appearing that they were entirely innocent.

Nelson Story's bank at Bozeman will henceforth do business under the name of the Gallatin Valley National Bank of Bozeman, having recently received its charter under national law.

An escaped Chinese murderer from Missoula was harbored in Bozeman a week by a brother celestial, until finding that his secret was known he skipped out.

Governor Crosby to-day refused to pardon George Wells, convicted of burglary of Henry Elling's bank at Virginia City in 1879 and sentenced to ten years imprisonment in the Deer Lodge penitentiary.

An eastern exchange says: "Go on Change, in Boston, New York, or Philadelphia nowadays and shout, 'Hi, you mister from the west with a copper mine for sale!' and over half the men on the street will turn around and say, 'what do you want!'"

A gentleman just from Lake Coeur d'Alene says that there is a tree out there which is a promising rival of California's big trees. It is a cedar and is seventeen feet in diameter, which would make it over fifty feet in circumference. That country is full of fine timber.

Exchanges from all sections of the Pacific coast report the old prospectors are getting the Coeur d'Alene fever badly and parties are forming to be on the ground early in the spring. In California particularly a general rush for the new gold fields is expected next May. An estimate based upon reports of parties forming in various sections, places the number of prospectors, miners, traders and adventurers who will be in the new camp by June next at not less than fifteen thousand.

From a private letter received from Radersburg we learn that Jefferson county officials are in quite a muddle over the county seat removal from Radersburg to Boulder. It seems that the bill authorizing the removal made no provision for canvassing the returns of the election held under it, and as a consequence the matter has gone by default. Several of the officials have left for Boulder, however, and the Radersburg folks contemplate contesting matters and setting up that the absent officials are violating the law, which imposes a fine of \$5.00 a day on officers who do not keep their offices open at the county seat.—Courier.

THE LATEST NEWS.

There are two cases of yellow fever in the San Francisco Marine hospital.

Edward Payne, cashier of the Rushville, (Ind.) bank, was shot in the lung by a burglar, who attempted to rob the bank.

At Kincardine, Ont., the boiler of a tug exploded, killing four persons and precipitating the others on board into the lake.

The Canadian authorities seriously consider the advisability of sending destitute Irish emigrants back to the old country.

Great rains are reported in Indiana that have flooded the streams, causing them to overflow their banks and destroy property.

A dispatch from Duluth says it is believed that the steamer Manistee has been wrecked and the twenty-five persons who comprised her crew drowned.

Ex-Senator Spencer, of Alabama, has been arrested for contempt of court in not appearing to give evidence in the star route cases. He has been taken to Washington.

It is rumored that the St. Paul, Minneapolis & Manitoba railroad has been sold, and on the first of January next will pass into the hands of the Chicago, Milwaukee & St. Paul.

Southern Missouri and northern Arkansas were visited by a destructive cyclone on Wednesday evening. The town of Melbourne, Ark., was completely destroyed, one man killed and several injured.

The Chinese ambassador has received a reply to the last French communication on the Tonquin question of China, and makes fresh proposals, which are not in any way acceptable to the French government.

The strikers at the Iron Mountain, Mich., mines are to be dispersed by militia. They number 15,000 and demand full pay without deductions for board or store accounts. They have stopped the pumps and the mines are filling with water.

The verdict of the coroner's jury in the case of the men killed by the capitol at Madison, censures the architects for gross negligence in causing the piers to be improperly erected and for designing the internal erection without regard for safety during erection.

The pool known as the Consolidation Paper company, comprising fifty mills throughout the northwest, manufacturing wrapping papers, met in Chicago on the 21st, and resolved, in view of the overstocked condition of the market to shut down all mills from December 1st to February 4th that have been running on half since November 1st. This measure will throw 2,000 men out of employment.

The firm of Mickels, Friedlander & Co., wholesale dealers in furnishing goods, of San Francisco and New York, made an assignment in favor of their creditors. The failure is due to heavy indorsements for Healein & Co. and S. Lautenback, of New York, both firms having recently failed. Their liabilities are \$400,000, of which half is New York indebtedness. Mr. Friedlander says their assets are \$650,000. Everybody will be paid in full. The firm has been in existence for thirty years.

The following is an extract from a letter sent by the Chinese minister to the secretary of state: "If France desires to maintain friendly relations with China, why should we not discuss the matter amicably? If she insists upon invading the northern part of Annam, where our troops are stationed, it indicates that she is determined to break the friendly tie, and our troops there cannot remain with folded arms, but must meet them in the field. We therefore send this communication to all foreign powers, showing that should the friendly tie be broken, the cause of the rupture does not come from China."

They are bound to shut down on cattle killers across the border. The Fort McLeod Gazette says Col. Irvine, Stipendiary Magistrate, sentenced a man to two years imprisonment in the penitentiary for killing a steer.
