ST. CECILIA'S YEAR ENDS

The Twenty-Ninth Annual Commencement Yesterday. MGR. MARTINELLI PRESIDED

A Long and Varied Musical Program—List of Graduates and of Those to Whom Certificates and Premiums Were Distributed—The Clergy Present at the Exercises.

The twenty-ninth annual commencement of St. Cecilia's Academy was held last evening at the Columbia Theater. The apostolic delegate, Mgr.
