GRANGERS THE LEADERS

Money and Stock Markets Appreciably Firm.

Transactions Largely Influenced by Orders From London Houses - The Wheat Yield.

New York, Dec. 13.-The Treasury statement for November for expenditures of the country's principal domestic articles showed a total of \$82,323,699, an increase of more than \$5,000,000 over October's exports and an increase of \$6,000,000 over November, 1896.

The stock market was very firm to day. London houses being a fair amount of stocks, which circumstance was effective in shaping boardroom sentiment. The money market was appreciably firmer for loans on call.

The grangers were the real leaders of the day, and other conspicuous features were Union Pacific, Metropolitan Street Railway, Northern Pacific, People's Gas and Sugar Refining. Manhattan was untried in the early dealings, when its weakness affected the whole market, but it fully recovered its position in the afternoon.

Consolidated Gas was rather active and was weak on selling, reasonably supposed to be due to the policy of the management in the anticipated disposition of the company's treasury stock. Official information in this regard is still awaited. The market was marked by early fractional reactions and the close was firm at about the best figures of the day.
