### LATEST TELEGRAMS.

#### Miscellaneous.

Chicago, 11.—The steel rail mill of north, and the Chicago rolling mill, at South Chicago, a very large concern, shut down to-day, owing to the quiet state of the rail market, because of doubt about the tariff action of Congress and because no definite schedule of wages for the next year has been fixed. The furnace is still in operation.

John S. Steers, a bookkeeper for Martin Bros. stock yards, was arrested on a charge of embezzling \$5,000.

Rev. T. Dewitt Talmage lectured here this evening, subject: "Is the world growing better or worse," taking an optimistic view.

Inter-Ocean East Taws, Mich.: Snow storm here thirty-six hours; snow nearly three feet on the level.

Cambridge, O., 11.—W. C. Hazer, school teacher, got into a general fight with his pupils to-day, while trying to discipline them. He stabbed and killed John Hayes and severely cut Charles Luce.

St. Louis, 11.—The coal miners at the Belleville, Ill., district, hold a meeting here to-morrow. It is understood they will demand a uniform rate of three cents per bushel from January.

Janesville, Wis., 11.—Harvey Clifford, gambler, of Milwaukee, found guilty of murder in the first degree for killing Capt. Pugh, of Racine.

Boston, 11.—The receiver of the Pacific National bank has attached the properties of the National Security Bank to the twenty million. He alleges that the Pacific bank had in its possession checks and deposits at the defendants to the amount of \$11,000. The Pacific bank at the time contemplated insolvency and transfer was fraudulent.

Philadelphia, 11.—Gibson & Co., whose distillery was burned to-day at Gibbstown was insured for \$75,000.

Milwaukee, 11.—Officials of the Milwaukee and St. Paul Road stated that the rumor that freight rates are being restored are unfounded. No orders were received from New York. The general belief is that a schedule of rates has been prepared to go into effect at a moment's notice, upon a dispatch from Manager Merrill.

At noon, to-day, the last spike was driven on the new Milwaukee and Lake Winnebago line, giving the Wisconsin Central Road an independent outlet from this city.

#### O'Leary and Murphy.

Washington, 11.—A citizens' committee had an interview in the jail, to-day, with O'Leary and Murphy convicted as card monte and bunco men. Each detailed the circumstances of many robberies, including the government printing office money theft, and gave the names of thieves and detectives who "stood in" as well as the percentage of the proceeds of robberies; paid detectives 20 per cent; detectives, it was even said planned some jobs and selected men to execute them.

Murphy and O'Leary gave a circumstantial account of the Christmas diamond robbery, and alleged that the diamonds of the ex minister were valued at from \$15,000 to \$20,000, and were disposed of at a great sacrifice in New York, and a heavy percentage given to two detectives, who were named. The wives of these men, O'Leary said, now wear dresses made from the silk taken in the Burdette robbery, and given to the detectives as their part of the plunder. It is alleged the entire detective force of the district received dividends levied on bunco and monte men. The detectives involved are the same ones dismissed for betraying government's interest in the star route cases Magruder, a member of the committee, thought he recognized O'Leary, who is well educated, and asked him if he had ever been alleged. O'Leary answered, "At Conzuga College." "Then," said Magruder, "we were college mates. I now remember you well." O'Leary seemed greatly mortified at this identification.

#### Kalaksua's Outfit.

Omaha, 11.—King Kalaksua's chamberlain, Col. C. H. Judd, who, with his party passed through Omaha yesterday homeward bound from Europe, has, as we learned from some of his acquaintances here, purchased in Europe some of the necessary insignia of royalty—a crown, sceptre and robes for Kalaksua. The robes and royal diadem will be used at the coming coronation of the King and Queen. They are modelled after those of Russia. The crown to be worn by the King is larger than that to be worn by his consort. They are each oval and ornamented with a cross at the apex brilliantly studded with a diamond rim encircling the head, solid gold inlaid with diamonds and other precious gems. The King's sceptre is composed of solid silver, inlaid with gold; the robes are purple with ermine border. The King was crowned according to the customs of his own country, but on February 22 he will be again crowned in style that prevails in the courts of Europe. Invitations to attend the coronation have been sent to the President of the United States and to the different rulers of the old world. The ceremonies take place in a new palace which is a magnificent structure. It was furnished by a Boston firm.

#### The Royal Party.

San Francisco, 11.—Colonel De Winton of the royal party, says that the movements of the party are undetermined. It is thought the Princess' health will induce her to winter in some warmer climate of this continent. The Marquis will shortly return to Canada to be present at the opening of Parliament. All engagements of the party are cancelled.

Washington, 12.—A report is in circulation to the effect that the Marquis of Lorne asked the secretary of war, by telegraph, to give the Princess and himself a military escort from San Francisco to San Antonio, Texas, fears being entertained that the Fenians are plotting against their lives, and will take the occasion of their intended journey to carry their plot into execution. This may be only a rumor, but it is a fact that an escort of one officer and ten men have been detailed to accompany the distinguished visitors.

#### Illinois Senatorship.

Chicago, 11.—Senator David Davis stopped in Chicago a few days ago, and during a call on long John Wentworth, discussed his chance for re-election. The independent senator does not consider his re-election improbable. Republicans are said to be of the opinion that they have with seventy-seven votes a clear majority in the House. On the other hand it is claimed that the republicans even with the seventy-seven votes cannot elect a speaker without the selection of a candidate who will vote for himself. Furthermore, it will be disclosed, so good authority says, when the republicans come together at Springfield that two of the men counted among the seventy-seven will act as independent republicans, and will control the speakership. The men that give away the speakership will expect and get the senatorship in return. The same authority in answer to a question whether the majority in the senate on joint ballot will not settle the senatorship, said the house cannot be compelled to begin joint balloting. The house may say it is not ready to go into joint session and then there will have to be a compromise, concluded the speaker.

#### WASHINGTON.

Washington, 11.—M. C. George, Oregon, introduced a bill providing for the sale of a piece of government property in Upper Astoria, Clatsop County, Oregon, acquired as a site for a custom house.

A petition was presented to Congress by Ephraim Bishop, of California, asking for remuneration for the machine invented by him for the late war for deepening rivers and harbors. He claims \$300,000.

Page presented a memorial from the state board of Regents California, University, asking Congress to modify the law so that they may invest the funds derived from the sales of lands in securities and find a lower rate of interest than 5 percent.

#### Sturka—Died Inane.

Chicago, 11.—Several more eminent physicians gave testimony to-day that Teresa Sturka was sane when she shot Stiles.

Josiah A. Noonan, for many years the most prominent politician and journalist in Wisconsin, died this morning in the insane asylum at Mawantosa. His unfortunate business ventures and vindictive lawsuits brought on insanity. Several years ago he was best known in national politics as a staunch western friend of President Johnson, when the latter swung 'round the circle.

#### Casualties.

Bridgeport, Ct., 11.—By a cave in the wall of a well, Edward English and his son James, of Danbury, while they were digging, were both buried. After eleven hours work the son was rescued, and after fifty hours the father was found alive, but another cave killed him.

London, Ont., 11.—Amberstburg Crossing, on the Canada Southern Railroad, is blocked with snow and ice. A train of twenty-six cars of cattle are held fast in the river, and are in a deplorable condition.

#### The 'Jeannette'.

Washington, 11.—Before the Jeannette court this morning, Nindermann testified that Collins was always treated like a gentleman and an officer so far as he knew. He then described a little difficulty which he (Nindermann) had with Captain DeLong on Sept. 23th, 1881, but said it only amounted to his being placed under arrest for an hour. His examination was closed and it is expected the court will be occupied several days reading the testimony.

#### Confirmations.

Washington, 11.—The Senate, in executive session, confirmed a large number of nominations, including General Pope and Colonel Mackenzie, to be major general and brigadier general respectively.

#### Bank Robbery.

Kinsley, Ka., 11.—Edwards County Bank was entered on Saturday evening while the cashier was at supper and the vault opened by working the combination and robbed of \$12,000. Parties are suspected and it is thought the money will be recovered.

Topeka, 11.—J. C. Ellis, of Kinsley, Kansas, tells the following story of the robbery there on Saturday night: L. G. Boice, the cashier, locked the safe and vault, and went to supper. G. W. Crawford, county treasurer, has an office in the same building, and besides the cashier, is the only one acquainted with the combination of the lock. He left at the same time with Boice and returned with him, and found coins scattered round the room. Boice opened the vault and found \$12,000 missing. The burglars evidently entered through the treasurer's office in the rear—a panel between the two rooms having been broken. It was evident the door of the safe was unlocked, not broken, so the burglars must have had the combination. Detectives set to work, and it is reported the money is recovered.

Larned, Kansas, dispatch: Intelligence was received here, to-day, that the robbery of Kingsley Bank had been traced to the county treasurer, J. W. Crawford, of Edwards County, by means of a bunch of keys and a glove dropped at the door of the vault, and that Crawford has acknowledged himself guilty, and agreed to surrender the stolen money which seems to be hid away somewhere out of Kinsley. This rumor is supplemented by many others, and is hard to determine just what the facts are from this distance. It is accepted as conclusive, however, that Crawford, in some way, is implicated with the robbery, if indeed he himself is not the robber, and that the facts will be finally developed and the funds probably recovered. At present Crawford is kept under guard at his residence in Kinsley.

#### The Coming Mill.

Chicago, 11.—A reporter, this afternoon, interviewed Jim Elliott, who is to fight Allen in the coming contest. He started off with the assertion that he would fight any man in the world, with naked fists for \$2,500, and would not bar any one. Sullivan he did not consider champion at all. In his estimation Sullivan was the best man he knew with gloves, and admits that Sullivan was better with gloves than himself. Elliott says he does not believe Sullivan or any other man can knock him out in four rounds, or in fact in any number. Fox, it is said, is willing to match Allen against Sullivan at any time for \$1,000. Elliott says he will return to Chicago after his fight with Allen. His fight with Sullivan takes place on the 23d inst. The place where the fight will take place will be decided upon next Thursday.

#### The Work of Whisky.

A young man named Wm. Jones met with a terrible accident, last Friday, in this city. He had evidently been imbibing too freely and persisted in mounting a load of lumber that Mr. Jessie McCauslin, jr., was hauling from the depot along J street. Mr. McCauslin endeavored to persuade him from getting on to the lumber, telling him that as he was drunk he might fall off and get hurt. Jones, however, got on and had not proceeded far before over he went, and before McCauslin could stop the wagon, one of the hind wheels partly went over his head, crushing a portion of his skull. Had not Mr. McCauslin, who had been watching Jones closely, stopped the team when he did, the imprudent young man would, undoubtedly, have been killed. As it is he is in a dangerous condition. Fortunately, Dr. Pike was near at hand, and had Jones conveyed at once to his house.—Provo Enquirer.
