GOVERNMENTS HIGHER AND RAILROADS STRONG.

Chicago Live Stock. Union Stock Yards, Ills., March 13.—The week closes strong for fat cattle, which are selling at pretty fair prices and fully as high as a week ago, although the weekly receipts have been 2,600 head larger than last week. The demand for butchers' stock continues strong, and prices are well maintained. The receipts were light today, as is usual in the case on Saturday, and the few offered were taken at firm figures. Today hogs did what has been predicted for some time past—sold for \$1 per 100 pounds. The receipts were small, only 1,500 head, being estimated at only 3,000 head, and it did not take long to dispose of the supply at a 5c advance. Whether the upward movement will be continued or not, next week will probably depend largely on the volume of receipts. Feeders are feeling extremely bullish, and the bad condition of the country roads is keeping back large numbers of hogs. Only 124,800 arrived here this week after a 161,833 last week, 188,386 the preceding week, 152,900 a year ago and 187,000 two years ago.

Sid Larkins Sentenced to Be Hanged April 30. BUT FAINT HOPE FOR HIM. SALT LAKE FRAUD COMES TO GRIEF AT POCATELLO.

Fourteen-year-old Boy Pilfers From the Laramie Postoffice—Capture of Idaho Counterfeiters Cleverly Done—One of the Most Ingenious Schemes Ever Devised in the Annals of Crime—Death of Bishop Pace—J. E. Bromley Dies of Paralysis, Funeral Will Be Held Tomorrow—Other Occurrences.

Pocatello, Ida., March 13.—At Blackfoot today Sid Larkins, who has been confined in jail for the past year under sentence of death for the murder of his mistress, Josie Hill, at Idaho Falls, a year ago last Christmas, and whose case was taken to the supreme court, was today brought before Judge Standrod and resentence to be hanged on April 30. The only hope left for Larkins is before the board of pardons, but it is not believed that they will interfere and that the condemned man will suffer the extreme penalty of the law.

A Forger From Salt Lake. Pocatello, Ida., March 13.—W. G. Anderson arrived in Pocatello the early part of this morning, and presented Hageman a tailor of Salt Lake. He obtained the confidence of a number of Pocatello people and being short of funds, requested several of his new acquaintances to endorse checks which were drawn on the bank and bearing the signature of firms in Ogden and Salt Lake. One check was drawn for \$15 and endorsed by Mr. Woodworth, Assistant Superintendent of the office. Another for a similar amount endorsed by C. J. Balch of the superintendent's office, and a third for \$20 in favor of W. A. Rapp, the saloon man. All of these checks passed the cashier's office and were returned to the forger. The indorsees were obliged to stand the loss, together with the cost of contest. The parties who were swindled are very wrathful and promise to sue the forger. Mr. Anderson is being followed about by a gang of hoodlums, who are no doubt very highly entertained by their actions.

Young But Rather Tough. Laramie, Wyo., March 13.—A sensation was created here yesterday by the arrest of Charles Dayton, the 14-year-old son of Postmaster Dayton, by Post-office Inspector Waterbury of Denver. For some time small sums of money have been missing from the post office, which were spent by the boy and having no money, the inspector's attention was attracted to him, his arrest following. The boy last night confessed to stealing small amounts at different times, but he will be released if he can get the money back. The shortage is \$19, and young Dayton believes that he took that amount. An attempt will be made to let Dayton off, but the postal authorities are not sure of this. It is probable that the boy will be given a term in the penitentiary.

Counterfeiters Caught. Lewiston, Ida., March 13.—After a long search by a federal secret service agent for counterfeiters operating among the Nez Perce Indians, there are now in jail in Grangeville, Idaho, Eddy, Lou Eddy, James Eddy, Frank Freiligh and Charles Scroggins. They were located in the vicinity of Salmon Meadows, a valley bordering the Seven Devils mountains, where the detective seven feet deep. The detective worked with them until he was trusted to even cache the tools, and with James Eddy made a journey to the land of the Nez Perce to shove the counterfeit money. The sheriff seemed to have detected the fraud. The detective induced a stockman to arrest James Eddy on a charge of stealing cattle. The examination was deferred, and Eddy was detained until the detective could bring out the balance of the gang as witnesses on behalf of the alleged cattle thief. It would have been impossible to take the men in their rendezvous, but officers in the snowshoe journey they were all arrested.
