JONESTRAGEDY IN NEVADA

YOUNG GUINAN WARNED HIS SISTER AND JONES.

Rock Springs Man Sent to the Asylum—Great Demand For Coal Miners in Wyoming—Killing Deer in Nevada—Butte Policeman Breaks a Detective's Jaw.

Wyoming Press: On Thursday night near the hour of 11, Mr. Dan Cameron, the tailor, saw a bright light in the heavens, which looked to be just over the asylum. Calling his neighbors out, a dozen or more of them viewed the strange object until it passed behind the clouds which hung in the sky to the west of town, and in which direction it was traveling. Mr. Cameron avers that in its flight this strange aerial creature seemed to be under perfect control, that it would soar and dip, and then pursue a straight course. It is also sure that two lights were used, as when the machine seemed to come directly towards him, only one light could be discerned, and that at such times it was very brilliant, and would quiver like the headlight of a locomotive. When soaring, the lights were dim; two lights were seen when the object presented a side view, and were quite far apart, and when near together, as when the head pointed in his direction, only one could be observed. Mr. Cameron's statements are corroborated by at least a dozen who were eye witnesses.

KILLING OF C. A. JONES.

Julian Guinan Gives a New Account of the Tragedy.

Carson Appeal: Yesterday morning the preliminary examination of Julian Guinan before Justice Stone was called. Upon a motion of Attorney Chariz, the case was postponed until Monday morning at 10 o'clock.

The postponement of the case was at the suggestion of the defense, from the fact that the funeral of the late Charles Jones was to take place in Reno yesterday, and members of the defense did not want to seem to be rushing matters. Mr. J. A. Jones, father of the late district attorney, has expressed himself as deeply grieved at the sad outcome of the affair, but, furthermore, does not feel any animosity toward the Guinan family in their hour of trouble, and it was partially at his suggestion that the case was postponed.

In this France watches Germany, and Germany France, while Russia and Austria watch the other side of the Atlantic.

HILLMAN BROUGH.

Reads a Paper on Irrigation Before Scientists.

Hillman Brough, son of ex-Mayor Brough of Ogden, delivered an address before the Academy of Science in Baltimore last week. The Baltimore American contains a column write-up of the discussion on the subject, "Irrigation for the West," which was held at the Academy of Science in Baltimore, and devoted to reproducing passages from the address of young Brough, though such distinguished scientists as Dr. P.
