Rebate Plan on Colonist Traffic May Fall Through.
MUST SECURE APPROVAL OF INTERSTATE COMMERCE COMMISSION BEFORE ENFORCED.

As announced Thursday morning, the rebate plan, which the Missouri river line has adopted in connection with the sale of second-class tickets from the river, the rate to north Pacific coast points having been fixed at \$15, to meet the competition of the northern line. But a new phase of the situation now presents itself. In order to protect regular rates to intermediate territory, the Missouri river line decided to sell rebate tickets from all points east of the river, charging regular local rates from the starting point to the river. As the amount of the rebate to be paid in many instances would make the rate higher for a short haul than a long haul, the plan, it seems, must first meet with the approval of the interstate commerce commission. Passengers on the Missouri river line are confident that such consent can be secured, but those of other roads claim that the commission, basing its action on former experience, will not recognize the alleged necessity for these lines to make the rate to the coast lower than to the river.
