ATLANTIC TO PACIFIC

Transcontinental Railroad Plans of the Harriman Syndicate. Then This Road Will Be Welded With the Union Pacific and the Chain of Railways From New York to the North Pacific Coast Will Be Complete.

Chicago, Sept. 10.—The Chronicle says: It is said by prominent railroad men that the Harriman syndicate is quietly working on a plan for a transcontinental railroad system. This is to be brought about by the extension of the Illinois Central railroad to Omaha. The latter company has its line to the Missouri river now but it is not until the latter part of the year that the connecting link is completed.

Chicago will be the center of this great system. From it the lines will radiate to the Atlantic and Pacific oceans and two routes from Chicago to the Gulf of Mexico will be opened up. The syndicate's system will also be strongly aided by the Missouri Pacific and the Missouri, Kansas & Texas, the two largest railroads in the southwest, with the purchase of the Minneapolis & St. Paul, which will also be a part of the system.
