CHINA TOWN IS IN QUARANTINE

Health Officers Discover Diphtheria in Plum Alley.

POLICE WATCH JOSS HOUSE

MONGOLIAN PHYSICIANS DOWN WITH THE DISEASE.

CHINA TOWN is under police quarantine as a result of the discovery of diphtheria in the Celestial quarters of Plum alley.

The quarantine officers tried in vain to enforce an observance of health regulations, but they didn't have brass buttons enough to satisfy the Chinese boys as to their authority.

The victim of the disease is the Chinese physician, an aged son of the Orient, who also holds the ecclesiastical position of high priest in the temple of Joss, and acts as a fortune teller and seer for the worshippers of the war god.

The sick man was discovered in the dingy, smoke-filled recesses of one of the dives yesterday and the matter was immediately reported to the health department.

As soon as the nature of the disease was discovered a flag was placed on each door of the house and the Chinamen were instructed to keep away from the place.

Expostulations and threats were in vain, for the Chinamen had to be shown. The quarantine officer flashed his star of authority, still the Celestials were not convinced.

The presence of an officer had due effect, but it is feared the devils will find some means of getting into the place unobserved and spread the disease.

Aside from this threatened outbreak of disease the health of the city is exceptionally good, according to the reports of the health officers.

HEALTH OF THE CITY.

Slight Increase in Scarlet Fever, But Falling Off in Diphtheria.

For the week ending April 12 there were twenty-one deaths reported in Salt Lake City, of which fifteen were males and six females.

At the close of last report there were nineteen cases of scarlet fever in quarantine. During the week thirteen new cases were reported, two died and nine were released.

Of diphtheria there were three cases reported during the week. At the close of last report there were fourteen cases in quarantine and six having been discharged left eleven cases in the city.



MURDER OF AN AMERICAN.

Washington, April 12.—Save the short telegram of Thursday from Consul Malmros at Colon, the state department is without advice from the isthmus in regard to the killing of an American citizen when the American steam launch was seized by Colombian insurgents at Boac del Toro.

However, the fact that Mr. Malmros' telegram did not mention the killing of an American citizen by the insurgents has made the officials doubt the statement that the person was really an American, for they argue that the consul would surely have mentioned a fact so important.

It turns out, however, that an American has been killed by the insurgents as reported, then the state department will deal more sternly with the situation on the isthmus than it has heretofore. The Philadelphia is on the Pacific side of the isthmus, and the Machias will probably arrive at Colon today, if she has not already done so, and if this naval force is not sufficient to effectively protect American life and property, more ships will be sent to Colon at once from the North Atlantic squadron.

MEAT FAMINE IN LONDON.

Brittishers Are Made to Feel Claws of American Trust. London, April 12.—The so-called meat famine, which has been exploited throughout the British press, has become a matter of keen interest to Londoners, who hitherto have not been affected by the prevailing scarcity.

A careful analysis of London shows that the retailers at the present time are the sole sufferers by the advance in the wholesale price, which amounts to a penny per pound on all grades of meat. Since January the majority of the retailers have been running their business without profit, because lack of organization prevented a uniform increase of prices.

BILL HAS HIDDEN MEANING.

Representative Littlefield Criticizes the "Anti-Injunction" Measure. Washington, April 12.—Representative Littlefield of Maine has filed a minority report from the house judiciary committee on the bill known as the anti-conspiracy and anti-injunction bill.

The majority report is full of protestations of friendship for and sympathy with employees, but we fear that the employees, when they realize the infinitesimal character of the alleged relief that the committee believes it is giving them, may reach the inference that these protestations are entitled to some discount.
