DELEGATE GAIN AND LOSS.

Some Republicans Trying to Account For Apportionment.

The Republicans have been studying the county convention apportionment of the county committee Saturday afternoon, trying to try to read between the figures. And with more or less success. That the apportionment is not considered altogether satisfactory is evinced by the objections which have been registered on all sides by the district leaders and the "whippers in."

Although the First precinct is the only one which has had its representation decreased, the leaders in the other four city precincts are jealous of each other, and are trying to get their own to be uniform. Just what the Republicans propose to do about it remains to be seen, but several vigorous attacks are to be registered, even if they do not accomplish any good.

In the eleven districts of the First precinct there is a loss of six delegates, with a gain of five, making the net loss one.

In the second precinct the loss is two, with a gain of three, making the net gain eleven.

A loss of two in the Third precinct is offset by a gain of five, making the net gain three.

WIFE OF EX-CONGRESSMAN KING TAKES SHOT AT AN IMPUDENT BURGLAR

Prompt and effective action on the part of Mrs. W. H. King, wife of former Congressman King, who lives on Military avenue in Popperton, prevented the burglar of her home early yesterday morning.

Mrs. King was awakened from her sleep early yesterday morning by the sound of a heavy object falling into the cellar. She arose quickly and, seizing a revolver, which she had kept in her room as a matter of precaution, rushed to a window to see the cause of the disturbance. Without warning her unwelcome visitor, she raised her weapon and fired once at the figure. Like a flash she dropped again quickly into the cellar. SALONS WIDE OPEN YESTERDAY

Police Close Eyes to Violations of the Law.

SIDE DOOR FARCE ABANDONED

PATRONS REACH BARS NOW THROUGH FRONT ENTRANCES.

IN OPEN VIOLATION of the orders of Chief of Police Paul, a number of the prominent saloons of the city were wide open yesterday. No effort whatever was made to conceal the fact from either the officers on their beats or from anyone else.

It was ordered that it should be a dry Sunday yesterday, but no special attention was paid to the order. If anyone went dry it wasn't the fault of the police, but of the saloonkeepers, for they did their part by being the latch-string on the outside for any who desired to enter. There was a cordial welcome for all, most cordial and sincere on the part of the saloonkeepers, for the side door farce was abolished in many instances and front entrances were opened.

Numbers of the saloons in the busiest part of the city remained open until midnight Saturday night, and the windows were drawn across the front windows, but the front doors were wide open and a steady stream of men poured in each month at Masonic hall at 7:30 p. m. Sojourning gentlemen are cordially invited to attend.

Some of the saloons were closed, but the large per cent which showed any disposition to obey the mandate of the chief were insignificant little shops, not rivaling in any way the more pretentious places, which flaunted defiance at Chief Paul. The officers on their beats have been able to shut up most of the grogeries, but many still remain open on Sundays. No effort is made on their part to force the most respectable and influential saloons into obedience of their superior's orders.

It has not been learned whether the matter is the result of indifference on the part of officers or the instructions which have been issued from headquarters. At any rate, the proprietors of the places, many of whom have been repeatedly arrested and found guilty in the city court have entered a vigorous protest against the grogeries.

Several drunks were arrested and taken to headquarters during the day, but no arrests for the violation of the liquor ordinance were made. A desk sergeant. No particular effort is being made by the patrolmen to apprehend any of the saloon men, who state that the state secretary is a matter of a short time till no further effort will be made by the police department to enforce the Sunday closing law.
