

BLOODY BATTLE WITH INDIANS

Wyoming Sheriff and One of His Deputies Killed.

WHOLE COUNTRY AROUSED

TROUBLE AROSE OVER VIOLATION OF GAME LAWS.

Denver, Colo., Nov. 2.—Five hundred men, including sheriffs' posse augmented by volunteers from the ranches adjacent, are scouring the country in the vicinity of Lightning creek, in eastern Wyoming, in search of the band of Indians which Saturday afternoon fought a battle with Sheriff Miller's posse, killing the sheriff and one deputy named Fossberg. The latest advice is to the effect that a second battle has been fought and ten Indians killed and eleven others captured, but this has not yet been verified. News from the scene of the trouble, which is twenty-five miles from telegraphic communication, is very meager. The Indians, seventy-five in number, said to be under the leadership of Charlie Carries Elk, are supposed to be Sioux from the Pine Ridge reservation in South Dakota. They have been hunting in the Converse country, Wyoming, in violation of the game laws of the state. Sheriff Miller's posse, sent to the scene of their depredations last Saturday for the purpose of arresting the Indians, the Indians had received information of the coming of the whites and prepared an ambush for them. The posse would have been entirely wiped out but for the fact that they were proceeding cautiously and were, in a measure, prepared for some trick on the part of the Indians.

Whites Sought Cover. At the first volley from the Indians Sheriff Miller and his deputies hastened to cover and then ensued a genuine Indian fight. The whites found refuge behind trees and boulders. It is thought that at least six Indians were killed and several others wounded, among the latter being Eagle Feather, a sub-chief. The battle lasted about an hour, when the Indians began to make their escape by ones and twos on horseback. They carried their dead and wounded with them and are now believed to be well on their way to the Bad Lands in Nebraska. The officers did not attempt to follow, but sent a courier to Lusk, the nearest telegraphic office, to bring a message to Governor Chatterton, apprising him of what had occurred. The news of the battle spread rapidly and every ranchman for miles around himself and joined one of the numerous posse hastily organized to punish the Sioux. The governor wired the interior department at Washington that the Indians must immediately be arrested.

Violated Game Laws. For the past two weeks the band of Indians has been in northeastern Wyoming slaughtering game in violation of the laws. In addition the settlers have been complaining bitterly that the Indians have been killing and stealing their cattle. Settlers warned the leaders of the band to leave the country, but the redskins only laughed at them. They claimed that the government had so reduced the amount of the rations that they were forced to kill game to keep from starving. Charlie Carries Elk, newly telegraphed to Washington, has driven two far, they would fight.

When Sheriff Miller of Weston county was notified of the refusal of the Indians to get out of the state and the threats made by them, he organized a posse, including R. D. Hackney, D. O. Johnson, Fred Howell, Lieutenant B. P. Hilton, James Davis, and started for Beaver creek, along which the redskins were encamped. On Friday the Indian camp was ransacked. It was deserted by all except the squaws, children and a few old men, who were busy skinning wild animals and preparing the meat for winter use. The entire camp was placed under arrest and sent to Newcastle, in charge of Lieutenant Hilton. The posse started on a search for the braves. They were located Saturday and during the afternoon Sheriff Miller and his deputies started to close in on them. When the whites got within rifle range of the Indian camp they were suddenly fired upon and the battle followed.

MONDELL NOT SURPRISED.

Washington, D. C., Nov. 2.—The Indian office today denied the following suggestion telegraphed by Senator Warren that a party of Indians committing depredations in Wyoming be taken charge of by the agent at Pine Ridge, S. D., if necessary. Representative Mondell said of the outbreak: "I am not surprised at the news. The trouble is being taken charge of by the authorities, adjoining our state, the authorities grant leave of absence to the Indians. They think that by coming to hand, in violation of the game laws. The state authorities had not wished to deal harshly with the Indians. It certainly has been the custom to send out a man to warn them against the whites, got their warning lately has been without avail. The Indians laughed at sheriffs or posse. When I left home a few days ago I heard that a posse had been organized to arrest the Indians, and had determined to use force if necessary. From what I saw this morning there was evidently a bitter fight. The authorities of the Pine Ridge agency are responsible."

MAY BE CROWS.

Nothing Definite Known Regarding the Indians. Washington, Nov. 2.—The general land office has received a telegram from Senator Warren of Wyoming regarding the depredations committed by the Indians and the authorities in eastern Wyoming. The telegram says: "Reliable information just received by Governor Chatterton reports that the Indians had been illegally hunting on Lightning creek, forty miles from Lusk, on the Northwestern railroad. Sheriff Miller was seriously shot through the hip by the Indians, and a member of his posse, Falkenberg, was killed. Three Indians were killed. The remainder of the party are at large in Wyoming and are supposed to be headed eastward toward Crawford, Neb." Senator Warren suggests that the Indians should be arrested, and he expresses the opinion that they can be reached either through Indian agents or the military authorities. The Indian officials here believe that the Indians involved are a band of Crows on their way to the Pine Ridge agency to make a visit. It is thought that their meat supply was exhausted and they were hunting to obtain food.

Chatterton Waiting. Cheyenne, Wyo., Nov. 2.—Governor Chatterton is waiting for additional information before ordering troops to the scene of the trouble with the Indians. The governor has called on the commissioner of Indian affairs to assist in

bringing the murderers to justice. He will also insist that no more Indians be permitted to leave their reservations to hunt in Wyoming. Under the law every Indian outside of the state must take out a gun license which costs \$50 and go with a professional guide when they hunt. It is held that every Indian who fails to do this violates the laws, and the general government as guardian of the red men is responsible to the state for the payment of the license. The present trouble has been brewing for a long time and now that the Indians are aroused it is feared there will be a serious outbreak before they are made to understand that the laws must be respected.

CHARGE OF EMBEZZLEMENT

Prominent Citizen of Pocatello Arrested. (Special to The Herald.) Pocatello, Idaho, Nov. 2.—William A. Norton, for a long time manager of the Studebaker Wagon & Buggy company at this place, was arrested Saturday evening, charged with the embezzlement of \$2,200 of the firm's money. He was given a preliminary hearing before Probate Judge Johnson this morning and released on \$200 bail. He was bonded by a surety company, which, it is stated, has already paid the amount of the shortage claimed. The surety company will prosecute the case. The greater part of the delinquency has been within the past few months. He has been considered a good man previous to this charge having been made. SANTA FE AROUSED.

Large Reward Offered For Capture of Train Wreckers. Denver, Nov. 2.—A reward of \$5,000 is offered by the Santa Fe railroad officials for the capture and conviction of the persons who caused the wrecking of the eastbound passenger train from Denver at Ashbapa Creek last Friday. "I am at a loss to give a correct theory for the wrecking of the train," said General Manager Mudge, "but there is no doubt about the thing being deliberately planned. It is a most dastardly outrage, as hundreds of lives were placed in jeopardy, and the Santa Fe road will not stop until the mystery is sifted to the bottom. Paris, Nov. 2.—The almost complete paralysis of the telegraph system on Saturday last is attracting the attention of numerous scientists, including Camille Flammarion, the astronomer, who attributes it to magnetic disturbances caused by huge sun spots which crossed the center meridian of the sun on Saturday. Eugene Antonioni, formerly a co-worker of M. Flammarion at Juvisy, says the disturbance was due to a magnetic storm caused by a group of sun spots 125,442 miles in length. The largest sun spot, according to M. Antonioni, was 37,260 miles long.


