Cheyenne, Oct. 28.—G. Wakimoto, who is in charge of hundreds of Japanese employed as section men and in other capacities on the Union Pacific railroad, has been notified by the Japanese consul that all members of the First and Second army reserves are ordered to return home at once for military service.

Mr. Wakimoto says that over fifty members of the two reserves are located in Colorado, under 600 in Utah and about 500 on the railroads in Wyoming.
