University Regents Plan to Give Them Part of Gymnasium.

APPROPRIATION TO BE ASKED

PROPOSED TO MAKE BUILDING SERVE DOUBLE PURPOSE.

The woman's building proposed for the University of Utah and for which the club women and the college women have been working for some time past, is to be given up and in all probability no further effort will be made for some time toward securing such a building.

This will not necessitate a change of plans as proposed for the building, although the women who have taken the most active steps in the matter will be given the privilege of suggesting any alterations in the plans as they now stand.

The action of the board is based on the proposition that if the women ask the legislature for an appropriation for a woman's building exclusively, their petition may jeopardize the chances of the regents obtaining the needed gymnasium.
