

FIGHT MADE ON WASATCH DRIVE

Three Councilmen Succeed in Holding Back Improvement. Council Committees Favor Increasing Expenditures by \$35,000.

NEW PLAN FOR SEWER SYSTEM

Will Make Total \$185,000. Proposition is to Put Main in Ninth South Street.

Councilman Rulon S. Wells, at last night's meeting of the council, endeavored to have definite action taken looking toward the construction of the proposed Wasatch drive, but he was thwarted by the obstructive tactics of Councilmen Black and Wood...

The sewer and special water committees of the council at a joint meeting held yesterday afternoon, instructed the city engineer to prepare plans for submission to the council at an early date as practical for the enlargement of the city's sewer system.

Councilman Wood also had objections to the resolution. He said he would never vote to cut any measure through the council until it had been reported upon by a committee.

The original estimate did not contemplate a main sewer on Ninth South street. Upon investigation the members of the joint committee found it would be more economical to build a main sewer in that street than to construct a number of laterals, which would have to be placed deep in the ground in order to connect them with the rest of the sewer system.
