Twenty-four Men Perished on the Scaffold at Odessa.

MANY OTHERS ARE DOOMED

GENERAL TREPOFF MARKED FOR THE GRAVE.

ODESSA, July 13.—Twenty-four leaders of the recent disturbances were hanged today in various prisons. Another batch of seventeen will be publicly executed upon the arrival here of General Ignatieff, president of the special conference for the revision of the exceptional laws designed for safeguarding public order.

The battleship Georgi Poliodonetz has arrived here with a fresh crew for the purpose of taking sixty-seven mutineers to Sevastopol for trial by court martial.

Light Sentences. Of 202 persons arrested and charged with robbery or incendiarism in connection with the disturbances, 100 were acquitted today owing to lack of evidence and twenty-eight were sentenced to imprisonment, 100 to time to include the two weeks, which they have already served in prison.

The extraordinary outcome of these trials is commented upon here. It is openly asserted that it is a political demonstration against the military government which is in power.

LIBERALS ENJOYED AT HIS APPOINTMENT.

ST. PETERSBURG, July 13, 12:35 p. m.—Emperor Nicholas has signed the appointment of M. Witte, president of the committee of ministers, to be chief plenipotentiary representing the Russian government in the peace negotiations to be conducted next month in the United States. The appointment, which was signed after midnight, clothes M. Witte with plenary powers.

Chief of the designation of M. Witte to head the mission was forwarded to the emperor by the emperor. M. Witte will take passage on the North German Lloyd steamer Kaiser Wilhelm der Grosse, which sails from Cherbourg July 25.

Man of the Hour. Sergius Witte, the Russian plenipotentiary, may be regarded as the leading liberal statesman of Russia. For the last fifteen years he has been one of the strongest personalities in the Russian bureaucracy, although his political fortune suffered a set-back when he was compelled to resign the portfolio of minister of finance in 1903, and again when, after being appointed president of the council of ministers in 1905, he was dismissed, his office gradually lost its importance, and he again had to resign and go abroad had been persistently criticized.

He had charge of the Standard and National "oil" companies here, he said. He had charge of the lubricating oil department and handled the business of the company.

REBATES WERE FREELY GIVEN. Sensational Testimony in the Missouri Ouster Case.

STOOD IN WITH STANDARD. HOW THE REPUBLIC OIL COMPANY DID BUSINESS.

KANSAS CITY, July 13.—The giving of rebates as a common practice to secure business was brought out today in the testimony of A. G. Shires of Marjetta, Ohio, traveling salesman for the Pennsylvania Refining company of Oil City, Pa., who was a witness in the Standard oil company, the Republic oil company and the Waters-Pierce Oil company from the State of Missouri.

Paid a Rebate. Mr. Shires was manager for the Republic oil company at St. Joseph, Mo., from November 1901 to May, 1902, and came to Kansas City in June as assistant manager for the Pennsylvania Refining company. He had charge of the Standard and National "oil" companies here, he said. He had charge of the lubricating oil department and handled the business of the company.
