General Treppoff Thinks Russia Should Be Satisfied With Peace.

NO CRITICISM OF TERMS

SOLDIERS WON'T BE BROUGHT HOME AT ONCE.

St. Petersburg, Aug. 31.—"Personally I am satisfied—thoroughly satisfied," was the emphatic response of General Treppoff, when asked for his opinion of the peace conditions.

Situation Not Serious. Speaking further of the effect of peace on the interior, General Treppoff maintained that the conditions were by no means serious.

Bitterness Will Wear Away. "It took a year and a half," persisted the general, "to get the present force to Manchuria. The troops will be equally long in returning."

Liberalism Must Learn. "The trouble with the liberals here in St. Petersburg is that they are not accustomed to obeying the law and have to learn that they must be obeyed."

Regarding the demand for freedom of the press, General Treppoff intimated that the restrictions were more imaginary than real.

When questioned on the subject of the rumors of impending changes in the ministry of the interior, the general denied the current report.

As the correspondent arose to leave, General Treppoff again reverted to the subject of peace, saying in conclusion: "Your president has done great work, magnificent work, and should be thoroughly happy and satisfied."

St. Petersburg, Aug. 31.—Judging from the press comment today on peace, it would appear that while pleased with the prospect of the removal of further bloodshed from the far east, a large portion of the public is unable to reconcile itself to the loss of territory.

Yesterday the people spoke of "to-day's shame," meaning peace. "Many of the utterances show evidence of regret that the peace has not been achieved."

Embittered by what they declare to be a dishonorable peace, the extreme patriots do not always refrain from criticizing President Roosevelt and the American people, who, they declare, have offended Russian sentiment by undertaking the Russian preparations, strength and ability to come with the Japanese.
