UTAH OPERATOR INVASES MEXICO

Alexander H. Tarbet Acquires \$1,000,000 Gold Property in Southern Republic.

MINES ARE A CENTURY OLD

ADJOIN BELGIAN COMPANY'S PROPERTY NEAR LA PAZ.

Alexander H. Tarbet of this city has just closed a deal for a gold property in the Lower California possessions of Mexico, reputed to be worth a cool million.

The properties purchased by Mr. Tarbet, and upon which the first heavy payment was made in the month of August, are known as the Testera and La Parra mines, which are an extension of the possessions of the El Progreso company.

Before going east several weeks ago Mr. Tarbet had been investigating the proposition, and when he finally dispatched Hugh H. Tarbet to La Paz it was with a certified check covering the amount of the first payment and in junction that, if certain features of the deal were as represented, to pay over the money and take possession of the mines.

The adjoining mines of the El Progreso company, in the southern district of Lower California, and in the Triunfo mountains, about thirty miles from La Paz. The purchase price could not be learned here, but men familiar with the proposition declare that it must be at least \$1,000,000.
