Books Open for Inspection.

It is alleged in the complaint that the stockholders have not had all the rights and privileges of stockholders and have not had full opportunity to inspect the books and minutes of the corporation.

Fraud is Denied.

The defendants deny that they have in any way entered into any fraudulent dealing with connection to the sale of the company's assets.


Refer to Previous Suit.

Few experiences possess the power to stir a thoughtful mind more profoundly than sitting through a protracted term of service on the jury of a criminal court.

What, then, are the influences that conspire to move the various minds of these twelve men taken at random from human society to a unanimous agreement (or a fatal disagreement) with regard to the evidence for or against a prisoner charged with crime?

The first and most powerful of these influences is that of temperament. The first swift glance one casts around affords a startling revelation of the variety of natural predispositions.

The first balloting is cast without discussion, and is therefore a trustworthy revelation of the effect of identical impressions upon varying receptive organs.

But it is in the moral realm rather than the intellectual that the temperamental and experiential differences present themselves.
