

An injunction restraining the county of Salt Lake from trespassing on the premises of Paula Sowadski, 1753 South State street, was issued yesterday morning...


The Zion Saving & Trust company was awarded a judgment for default against John Carlisle and others by Judge Ritchie yesterday for \$2,728.80...



When completed the light and power wires of the Utah Light and Railway company, now strung on poles along Main and intersecting streets, will be taken down and placed in pipes in the trenches...


