STORMY CAREER OF THE MORE SNOWS NEEDED FOR FARMS AND CATTLE RANGE PAIGE AUTOMOBILE IN WET TRAFFIC TO END

After more than a year's litigation Mrs. F. B. Ferrand, of Salt Lake, will lose her Paige automobile next Monday, when it will be sold at auction by Sheriff Brig Robinson to satisfy an order of the district court, District Attorney Dobbs announced today. The money received from the sale of the car will go to the state.

Mrs. Ferrand's automobile has had a short, stormy and eventful career. It has figured in two big "contraband liquor running cases" both of which came to a sad end as the result of the vigilance of Sheriff H. C. Peterson and deputies in Weber canyon.

The automobile was purchased by Mrs. Ferrand in Salt Lake in August, 1918. In October the automobile was seized in Weber canyon by Sheriff Peterson and deputies when it was found to be loaded with liquor. The drivers of the car were fined \$250 each and the liquor confiscated. The state was to confiscate the auto but Mrs. Ferrand's petition for the recovery of the car was granted by Judge

Farmers, stockmen and cattle growers of the intermountain country are becoming apprehensive about next summer's water prospects, it is stated. Forest service reports from Nevada indicate that in addition to the open weather, there has been extremely light snowfall.

Locally, the farmers are becoming alarmed, it is stated. Authorities have stated that the water situation promises to be more acute this summer than it was last year, and the present supply of snow on hills near Ogden has been declared insufficient to start springs flowing. A number of springs that dried up during last summer's drought have not yet started.

While the thawing has caused anxiety concerning the outlook for the coming summer, it has been the means of relieving the serious hay conditions which prevailed until a few weeks ago. The opening of winter ranges by the thawing enabled farmers and stockmen to conserve their hay supply. High prices for hay continue to prevail, it is stated, but the demand for this commodity is not so acute as it was some weeks ago.

KOREANS ATTACKING JAPANESE SOLDIERS

Bolsheviki Arm and Equip Hordes for Assault on the Nipponese Forces

LONDON, Feb. 9.—(By the Associated Press.)—Koreans in the northern part of that country have attacked the Japanese troops there, says a wireless dispatch from Moscow today, quoting an Omsk message. The population rose to aid Korean forces from Chinese territory, it is declared.

The Omsk message as given by the Bolshevik wireless, says that on February 6 bands of Koreans raised in Chinese territory crossed the frontier and attacked the Japanese. Masses of the population are joining the insurgents. It is added, the Japanese retreating and evacuating northern Korea.

WASHINGTON, Feb. 9.—Official dispatches received here today said a force of 2000 Koreans, armed principally with equipment furnished by the Bolsheviks, crossed into northern Korea from Kirin, Manchuria, and attacked a Japanese post of 700 men at night, killed 300 of them and routed the remainder.

WASHINGTON, Feb. 9.—According to these dispatches, the attack was the initiation of an active rebellion in Korea. It was described as "the beginning of a tremendous affair."

Several other clashes have occurred between the insurgents, greatly reinforced by recruits from the natives of the district, and troops forming Japanese frontier posts, the dispatches said. In nearly every case the Japanese were outnumbered heavily and were forced to withdraw after suffering heavy losses.

According to official information Bolshevik authorities are in close touch with the Korean leaders and are making every effort to provide their troops with adequate equipment.

Reports received here recently said the entire length of the branch of the Siberian railroad running from Vladivostok west through northern Manchuria had come under Bolshevik influence and that a movement was on foot to organize the local Bolshevik forces in combination with the numerous bands of Chinese brigands to invade Korea.

Three full Japanese divisions are in Korea but it is said in Japanese circles that these have been so scattered to maintain order that they probably could offer little immediate resistance to an invasion.

Officials here have known for some time that many thousands of Koreans who fled into Manchuria were meditating hostile action against Japan. While there is not real Bolshevik feeling among these people, according to the authorities they are so stirred by hostility to the Japanese that they probably are willing to join with any other elements in attacking them.


