COLONEL TELLS MEMBERS OF WEBER CLUB WHY GOVERNMENT DECIDED TO BUILD BIG FEDERAL ARSENAL HERE

Before a large assemblage of business men of Ogden at the Weber club today, Lieutenant Colonel C. R. Baxter told why the government decided to build an ordnance depot near this city. Lieutenant Colonel Baxter and Lieutenant Colonel Taylor were guests of the Weber club and Ogden Chamber of Commerce.

Warren L. Watis, president of the two organizations, presided at the affair and introduced the officers. Colonel Baxter expressed his pleasure at the opportunity of meeting the business men and briefly told the general story of the proposal to build the ordnance depot.

"Before the war we had practically no ammunition," said Colonel Baxter. "We had only sufficient for target practice but after the war we had left about \$7,000,000 worth of ammunition that had been manufactured during the period of the war. Naturally the question of distribution of the ammunition came up and several suggestions were made. First it was suggested that we sell to our allies but that was impossible because they also had more than they needed for peace times. A second suggestion that we sell to our possible enemies did not receive consideration as that of course was not desirable. The suggestion that the ammunition be disassembled and sold as raw material was rejected as being expensive and dangerous to human life. It was later suggested that the whole supply be thrown overboard but the suggestion that the entire supply be kept for future war use was decided upon and an investigation was started by the ammunition board.

Difficult Proposition.

"This proved somewhat difficult owing to the fact that we never before had any ammunition and had no policy of storage. At present the ammunition is stored at five depots along the Atlantic seaboard and it was decided to have it distributed at both the Atlantic and Pacific seaboard and also at inland stations. Ogden was chosen as the Pacific coast site for the depot owing to climatic conditions and excellent railroad facilities. TRAGIC ECHO IS HEARD OF RECENT SPORTS EXHIBITION

An echo of the recent wrestling match in Ogden and the little tragedy in the home of G. O. Loomis, is heard in the district court in the suit filed today by Ben Petre against G. O. Loomis, to recover \$500 alleged to be due for money loaned.

The complaint alleges that Loomis secured \$500 from Petre on January 1, which was to be repaid in about ten days after the match was held. A few weeks ago Loomis came to Ogden and was seized with temporary dementia. He was taken into custody by the sheriff's department and when the examination was held the court ordered Loomis be committed to the custody of the sheriff at Salt Lake. After the examination in Salt Lake Loomis was committed to the state mental hospital. Two days after Loomis was taken to the asylum, Mrs. Loomis took her own life. There are two children.

Friends of Loomis in Ogden said that it was worry over the financial affairs in connection with the wrestling match that caused his mind to become unbalanced.

LATE SNOWFALL AID TO WATER STATUS, SAYS EXPERT

Approximately ten inches of snow fell last night and this will produce water an inch deep when melted, according to F. Koristian of the forest service research department. He said that early winter snows necessitated a 12-inch snowfall to form an inch of water and that spring snows, being of greater water content, resulted in greater water production.

Mr. Koristian stated that snow on the higher elevations in the central part of Utah averaged about six feet in depth. In the valleys there is practically no snow, while the altitudes from the valleys to the highest points had snow averaging from a foot and a half to six feet in depth.

In southern Idaho, reports received prior to today's storm indicated that the snowfall in that section had not exceeded the snowfall for last year. Drouth was feared, but Mr. Koristian stated today that the present storm would supply a normal amount for that district.

In northern Utah, the supply will be adequate, he stated. While the late snows will melt quickly and will be available for use for early irrigation only, the snows of December are securely packed in draws and canyons in the mountains and will melt slowly, and unless unprecedented heat occurs during the early summer, there will be an ample supply for the season.

The recent storms have deposited considerable moisture all over the

state, he said. North of Salt Lake the precipitation has been mainly in the form of snow, while south of Salt Lake, rain has fallen in large quantities.
