

# REIGN OF TERROR

## Hussars Fire With Ball Cartridges on Liverpool Rioters

LIVERPOOL, Aug. 15.—A reign of terror exists here tonight and troops are pouring into the city to put down disorder. A special guard has been detailed to protect the landing stage of the trans-Atlantic steamers, which, it is asserted, the rioters have planned to destroy by fire.

Five prison vans, escorted by fifty Hussars, which were carrying riot prisoners from the police court to Waltham jail, were attacked tonight by three thousand members of the roughest class in Vauxhall street. The mob threw missiles of every description, and in defending themselves the Hussars fired.

At first blanks were used and then ball cartridges. One man was killed and many persons seriously wounded. The troops then charged with drawn sabers and cleared the street. So daring were the rioters that one of them tried to unhorse an officer, who was obliged to use his revolver, wounding the man severely in the head.

Another, but less serious affray, in which the troops again were compelled to fire, took place in Bond street. Only a few persons were wounded.

In each case, before the troops were ordered to fire, many of them had their faces streaming with blood from injuries caused by stones and broken bottles thrown by the rioters.

The rioter who was shot by an officer died later in a hospital.

Still another riot took place in the Everton district, where the mob was trying to stop the street cars. Several policemen were injured.

After a meeting of the strike committee tonight, Tom Mann, one of the leaders, announced that the committee did not wish to see a shortage of bread and milk in the city and had given permits to firms to move flour and milk on the understanding that only union men would be employed.

Shipping here is completely paralyzed. Late tonight there were persistent, but unconfirmed, rumors that the rioters had set fire to a ship.

The rioter who was shot by an officer died later in a hospital.

Still another riot took place in the Everton district, where the mob was trying to stop the street cars. Several policemen were injured.

After a meeting of the strike committee tonight, Tom Mann, one of the leaders, announced that the committee did not wish to see a shortage of bread and milk in the city and had given permits to firms to move flour and milk on the understanding that only union men would be employed.

Shipping here is completely paralyzed. Late tonight there were persistent, but unconfirmed, rumors that the rioters had set fire to a ship.

Servants, tonight, in spite of the agreements signed with the railways in 1907, decided to call a general railway strike throughout the country and save the companies twenty-four hours in which to decide whether they were willing to meet the men and negotiate their grievances.

This is the reply of the men to the decision reached by the railway managers of Monday night to refuse all concessions to their employees.

The situation has become so serious that already there is talk of parliament prolonging its session in order to pass special legislation dealing with industrial problems.

King is Deeply Interested.

King George is taking a keen interest in the situation, and today his secretary, Lord Knollys, called at the premier's office to discuss the situation with Mr. Asquith.

So acute is the situation in Liverpool that there are rumors that martial law will be declared there.

Manchester is suffering from similar conditions, except that there has been no rioting. It is estimated that 25,000 carters and railway men are out there tonight.

Numerous other towns have been affected by the railway strike today, while in the city the dockers' troubles are still acute. Other cities involved in railway strikes in addition to Liverpool and Manchester are Glasgow, Bradford, Chester, Sheffield, Bristol, Doncaster and Leicester.

### AEROPLANE RECORDS OF THE YEAR

A year ago the highest altitude attained was about 6000 feet, the greatest speed sixty-seven miles an hour, the longest continuous flight 245 miles in five hours, the longest over-water flight forty-five miles, and there was the largest number of passengers carried. Since then an altitude of 11,475 feet has been reached, a continuous flight of 288 miles, and an over-water flight of 1000 miles has been achieved, and as many as thirteen persons have been carried in an aeroplane.

Within the year past the most hazardous trips have been successfully accomplished. Snow-capped mountains, yawning gorges, rivers and lakes and sea and canyon cities have all been triumphed over by the intrepid aviator. The icy fastness of the Alps impeded the progress of such indomitable conquerors as Hannibal and Napoleon. But the daring and lamented Chavez, rising 7000 feet high and battling with wind and storm, soared over them in a flight that will always remain an epic in the chronicles of aviation. The Hart and the Pyrenees have become mere "bunkers" in the sport over which the aeroplanes raced triumphantly just a few weeks ago. Niagara Falls, the Irish sea, the Gulf of Mexico, Long Island sound and the Gulf of Genoa have all been flown over, and airmen have toyed with the surf of the Atlantic and the placid waters of the Pacific. As for the English channel, that immemorial barrier between England and France—it has been reduced practically to an aerial ferry. How the world applauded two years ago when Bleriot, talking the wings of the morning, cleared the distance between Calais and Dover, and dropped down upon the surprised Brits. Yet in the past twelve months the channel has been crossed and recrossed, not simply from coast to coast, but from capital to capital, as Pierre Priou, going from London to Paris, 250 miles, in a little over three hours, and as did Tom Sopwith, the brilliant young Englishman now in this country, who traced an air line from the Isle of Sheppey to Beaumont, in Belgium, 175 miles, carrying off a prize of \$20,000—William Menkel in Review of Reviews.
