ABE RUEF MAY BE BACK IN PRISON

San Francisco, July 2.—Abraham Ruef, former political boss, under sentence of fourteen years' imprisonment for bribery and at liberty on \$300,000 bail, appeared before Superior Judge Lawler today, in response to an order to show cause why he should not be remanded to the custody of the sheriff.

Ruef had been admitted to bail by Judge Cabanis on the showing that his health was impaired, that several members of his family were ill, and that time and opportunity were needed in which to prepare his appeal from the judgment against him. His appeal has been filed with the appellate court and he has not recently been confined to his home by sickness.

Ruef declared to Judge Lawler today that he was still very ill, and that confinement in the county jail probably would result in his death. After hearing his statement, the judge ordered that a medical examination of this physical condition be made and continued the hearing until next Wednesday.

LITTLE WILL CHALLENGE JOHNSON FOR LANGFORD.

Reno, Nev., July 2.—In a statement made today by Frank A. McEvery of Chicago, representing George Little, former manager of Jack Johnson, Little will receive \$30,000 in all from the heavyweight champion in settlement of the financial differences existing between the two men. It had been announced that Little had agreed to take \$16,500 in liquidation of all his claims against Johnson, which amount, according to McEvery, will be presented to Little by the manager of a San Francisco bank now holding the money paid by the moving picture concern to Johnson for his end of the fight films.
