WITNESSES IN BUMGARDNER DAMAGE SUIT TALK ABOUT THEIR TOWN AND THEMSELVES.

The James Bumgardner damage suit against the Salem Express for alleged defamation of character occupied the attention of circuit court all day Friday and was not completed at the time the court closed for the day.

MANUSCRIPTS WILL BE SENT TO CHARLESTON TO BE GRADED BY STATE BOARD.

List of Printed Questions on Various Branches as Prepared by State Board For Counties All Over the State.

The teachers' examination here closed Friday evening and the papers will be sent to Charleston to be graded by the board of examiners.

Questions not yet reported are as follows: Reading. 1—Define articulation, accent, pitch, emphasis and inflection, and name some characteristics of good reading.

2—Of the recognized "methods" of teaching reading, what one method or what combination of methods do you prefer? Give reasons. 3—Quote a stanza or paragraph from some favorite author and give the main facts about the author and the quotation given.

TIN PLATE MILLS WILL BE SOLD TOMORROW

AT BANKRUPT SALE BY THE TRUSTEE, THE WHEELING TRUST & GUARANTY COMPANY.

Steel Trust is Said to Be Among Bidders and Mills May Be Dismantled and Moved Away.

The Jackson Iron and Tin Plate mills will be sold here tomorrow at bankrupt sale by the trustees, the Wheeling Trust & Guaranty Company, in pursuance of an order issued several weeks ago by the referee in the case, George Johnson, at Parkersburg.

There is said to be a number of bidders and the steel trust is believed to be among them. The latter, if it buys the property, will likely dismantle the mills and move them away from Clarksburg. The sale will take place on the premises.
