The Davis Colliery Company, of which the aged West Virginian who aspires to second honors in the gift of the American people's president, is erecting large coal sheds and receiving bins for West Virginia coal at Fifty-ninth street and Lowe avenue. The work has just begun, and nonunion carpenters exclusively have been employed to do the work.

In addition to the nonunion carpenters nonunion laborers are also employed, and union business agents who have endeavored to force the Davis Colliery Company to hire union men have been notified emphatically that the instructions from Henry Gasaway Davis are that no labor shall be employed in the construction work that has any affiliation whatever with the trades union movement of the country.

Because of this firm position against unionism taken by the Davis Colliery Company, the United Brotherhood of Carpenters has taken the initiative in waging war on the national Democratic ticket and will proclaim it throughout the United States as not only unfair to organized labor but as discriminating against it unqualifiedly.

J. A. Metz, business agent of the Carpenters' District council in Chicago, discovered a few days ago that the Davis Colliery Company had begun the erection of a big coal warehouse on Fifty-ninth street and Lowe avenue. On investigation Metz discovered that a stockade was being erected around the property. On further investigation he learned that none but nonunion carpenters and nonunion laborers were employed, and he further discovered that the wages being paid the carpenters were almost beyond belief.

According to Metz the carpenters are receiving but \$2 a day for ten hours' work, whereas the union scale is 50c an hour for an eight-hour workday, or \$4 a day.

After reporting these facts to the Carpenters' District council Metz was instructed to interview officials of the Davis Colliery Company with a view to replacing the nonunion carpenters with union carpenters or to at least increase the wages of the men at work. Metz went to the office of the company in the Old Colony building, where he met E. C. Phelps, superintendent of construction.

"I learn that you are employing nonunion carpenters and are paying them only \$2 a day for ten hours' work," said Metz. "The carpenters' union would like to have that work. I also understand that H. G. Davis, candidate for the vice presidency of the United States on the Democratic ticket, is the president of your company. Can nothing be done to change your tactics?"

"Yes, we are employing none but nonunion men," Phelps is reported to have replied. "This work has been postponed for some time waiting to be financed, and until H. G. Davis gave the word it was not begun, but it is now under way, and I wish to inform you that I am under instructions to hire none but nonunion men. I will state that I have been compelled to hire union carpenters."

As soon as Metz learned the state of affairs he reported to the Carpenters' District council, and regretting that political phase of the situation, the carpenters prepared to publish the Davis Colliery Company throughout the country.

"I had no political ideas whatever when I began to investigate the Davis job," said Metz. "I did not even know at the time I began the investigation that H. G. Davis, the Democratic candidate for vice president, was the president of the company concerned."
