MAYLOTT THE CHAMPION

Was Honor of Being Champion Tennis Player of Men's Class in Y. M. C. A. in the Tournament Finished Friday Morning.

In some of the fastest and most brilliant tennis playing that this city has ever seen, the final championship of Clarksburg and vicinity was played off Thursday and Friday on the local Y. M. C. A. courts.

The men to come up for the championship in singles were Dr. H. E. Sloan and J. T. Maylott. The first set ended in favor of Maylott by score of 6-4. The second set went to Maylott with score of 6-4, making two straight sets for the local secretary. The series to decide the contest was for the best three out of five.

Up to the third set when the games were 4-4, it looked as a tripartite of the former sets was to be witnessed. Sloan surged ahead and took the lead, winning the set by score of 8-6. The fourth set was started and the first game was won quickly by Maylott.

At this juncture Maylott found that his opponent had a stitch in his side and under the conditions they agreed to finish the series the next day, which was done, and Friday morning at ten o'clock both men appeared on the court for the final sets. The score at the end of the decisive set was 6-1 in favor of Maylott, thereby giving him the championship, winning the best three out of five sets. The official referee of the game was Frank H. Rhodes.
