HATFIELD EXPOSES TRICKS OF THE DEMOCRATIC PRESS

Points Out the Garbled References to His Course in the State Senate.

STANDS ON RECORD

Which Shows That All His Efforts Were in Behalf of the Common People.

GRAFTON, Sept. 28.—Dr. Hatfield, Republican candidate for governor, after a big meeting he addressed here Friday, talked with the reporters on several interesting phases of the campaign, brought about by criticism of his opponents. In the pre-primary campaign I was criticized in an interview, by a Republican who opposed me for the nomination for governor. One of the criticisms made in this interview was relative to my voting in favor of postponing the resolution providing for an investigation of the bribery charges in connection with the election of Senators Watson and Chilton.

"I see that the Democrats are utilizing a portion of this interview, hoping to detract from the confidence which the people indicated that they had in me by the vote that was recorded in behalf of my candidacy over the entire state, and especially in the agricultural sections. It is noteworthy that the Democratic papers leave out that part of the interview which deals with the Watson and Chilton bribery charges, but print the other part of the interview in bold-face type and send it out over the state for the purpose of doing me an injustice. The dishonesty portrayed by the Democratic press in giving only a part of this interview to the public is in keeping with the principles and methods that are so characteristic of them in all their political actions of the past.

"As president of the State Senate, I tried to and was given credit for dealing fairly and justly with Democrats and Republicans alike.

"Appreciating the dignity and importance of the position, I felt it my duty, if it was within my power, to do that which would create harmony and concord, which are so essential in a legislative body to successfully accomplish the purposes for which it is assembled.

Democrats Deceived Doctor.

"When the resolution to investigate was reported from the House and it was reached on the Senate calendar in the usual order, Senator McIntyre moved that it be laid on the table, explaining that his reason for making this motion was for the purpose of amending the resolution, and in no way was the proceeding intended to do away with the investigation, as the charges which had been made by Democratic members, the press, and the public, should be investigated. All he asked for was time to amend the resolution before its passage.

"This assurance to the Senate was given by Mr. McIntyre and by Senators Wood, MacCorkle and Peterkin, who substantiated fully the explanation given as the reason for desiring the resolution laid on the table temporarily.

"Senator Sutherland interrogated Peterkin, asking him if he would call up the resolution in the event Senator McIntyre did not carry out his promise. Senator Peterkin assured Senator Sutherland that he would do this, and further, assured Senator Sutherland, and the Republican members of the Senate especially, that if Senator McIntyre did not call up the resolution, he himself would do so in order that these very serious charges might be fully investigated. Upon the earnest declaration of these leading Democratic senators, I had no right to doubt their veracity or honesty, or to question their motives. If I am not accustomed to suspect my fellowman, whether he be of my political faith or not, and after receiving the absolute guarantee of these gentlemen and senators, I thought that I could grant them the courtesy and favor what seemed to me then to be a very reasonable request, with a decidedly plausible argument accompanying it. I, therefore, voted to lay the resolution on the table, believing in the truth and validity of their personal guarantee and promise that the resolution would be called up and have the consideration of all at a very

Finer Constructed and Equipped Plant Than in Cities Twice Size of This

EVERYTHING MODERN

As a Brief Description of the Building and Its Equipment Shows

The new Bell telephone building has now been finished and every detail of the equipment has been completed. This building will mark the opening of a new era in telephone service. It can be found in any city of the size of Clarksburg. It has been built for a public use and will be open to the public for office this morning. People everywhere are expected to be present.

To a representative of the program who visited the new building this morning, everything surely looked spick and span, ready for everything in the way of telephony and telegraph service that can be expected.

The new building is located on Main street and presents a fine appearance. It is of brick and concrete and is absolutely fire proof. The brick in its construction is of buff color and a large stone is between the first and second floors bears the legend "Bell Telephone Company." Handsome brass signs at the top of the door bear the name of the company.

An elaborate fire escape has been placed on the rear of the building, and complete fire protection is installed, consisting of sand buckets, ladders for over the gutters, and chemical fire extinguishers.

In the basement which has been completely fitted out as a power house, floors are located the heating and power plants; a fifteen-horse power gas engine operating a large dynamo. The power plant is not, as a general thing, used, the power being supplied from outside. If, however, for any reason power could not be obtained from that source, the private plant may be rushed into service, the batteries charged and uninterrupted service furnished.

On the first floor is the business office and it is most modern in all of its appointments. At either side of the entrance, on the inside of the building, is a public telephone booth, which has been built in as a part of the building. To the left is the cashier's cage, farther along are the counters for telephone and telegraph business.

Within is the local business office of the telephone company, as well as the telegraph office of the Western Union Company, both of which are under the supervision of W. J. Thompson, the local manager.

On the second floor, which is approached by a fire proof stair-case is the terminal room and the operators' retiring room.

The cables entering the building through the basement are conducted through fire proof ducts to the second floor and into the terminal room, where the protective apparatus, testing equipment, relays, etc., are located.

Each line is connected to a lamp which is arranged so that when more than a normal amount of electrical current passes into the line, the wires are grounded and no damage may come either to the employees or the equipment. Similar apparatus at each subscriber's telephone serves to protect from damage that might otherwise be caused by lightning or high tension interference.

All the toll lines (those which connect Clarksburg with other exchanges) are looped through the wire chief's desk in the terminal room to facilitate testing them. This desk containing the testing equipment is one of the most expensive desks which may be found. The equipment is so fine and so highly developed that it is possible by use of it to locate, almost exactly, any trouble which may occur on a telephone line as well as to tell what the nature of the damage may be. The wire chief's desk, therefore, is to see that all lines and telephones are kept in working order and he is provided with a force of men to handle the work as well as the

TUMULTUOUS DEMONSTRATION IS ACCORDED DR. HATFIELD IN COUNTY OF UPSHUR TODAY

VERY STRENUOUS AT HEADQUARTERS

Week Ending Marks a Great Amount of Very Effective Work.

Tonight will close the busiest week that the managers of the Republican state campaign have put in since coming to this city and opening up headquarters. A remarkable amount of work has been accomplished this week, and the strenuous activity of Chairman Lakin and his efficient and hard-working staff is being felt in the party organization in every county in the state.

Last week closed with a meeting of the advisory committee, which was in session all day and part of the night. This is the board of directors, as it were, of the great campaign that the Republicans are waging. It is a very competent and business-like body, and it went over the details of the campaign, laying the plans with great care.

This week opened with a big meeting of the state committee. That body is composed of thirty-three members. These were elected by the voters of the party at the June primary and this was the second meeting since that election. The first meeting was held at Parkersburg, where the committee organized. That was a remarkable meeting in that every member was present. The meeting this week was only slightly less so, since twenty-seven out of the thirty-three were present.

Filling the places of the three electoral candidates who resigned was by no means the important feature of the meeting. That was quickly attended to. There was a mass of much more important business than that to be transacted and the committee gave its thoughtful attention to disposing of it. The reports made orally were generally favorable. The accuracy of these reports are borne out by the written reports from county and district leaders, and the whole are of such a character as to warrant the feeling that the state ticket, headed by the popular Dr. Hatfield, is in no

ULSTER DAY

Opens with a Calmness That Causes Both Sides to Be Apprehensive.

BELFAST, Ireland, Sept. 28.—Ulster Day, Orangemen's culminating day of protest against home rule, opened with absolute calmness that rendered unionists and home rulers alike apprehensive. Sir Edward Carson today wrote his name as the first to sign the solemn covenant of Ulster men which binds them to use "all the means that may be found necessary to defeat the conspiracy to set up home rule in Ireland." He was followed by many men who have become leaders against home rule in Ireland. Most of the shops and all big industrial works were closed so that the men might participate in the manifestation if they desired.

IN ALABAMA.

MONTGOMERY, Ala., Sept. 28.—Colonel Roosevelt reached the capital of Alabama at 6 o'clock this morning to renew his appeal to the South to support the Progressive principals.

BUCKHANNON MEET

Results in a Big Overflow and Nominee Sets Political Woods Afire.

BUCKHANNON, Sept. 28.—Dr. H. D. Hatfield spoke to one of the largest and most enthusiastic audiences that ever greeted a speaker in Upshur county in the court house here this afternoon. His plunge today into the central section of West Virginia was auspicious and spectacular from every standpoint. The Hatfield meeting here this afternoon afforded a striking comparison to that held by the Democrats on Thursday addressed by Mr. Thompson. Less than 100 were on hand to hear Mr. Thompson and the enthusiasm manifested over the Democratic candidate was not such as to lend any encouragement to the hopes of the Watsonized candidate. Today the court house would not hold the throng that turned out to hear the Republican candidate and an overflow meeting was necessary.

Dr. Hatfield was given a tumultuous demonstration significant in the fact that any factional lines that may have been drawn over the national ticket were broken and the unanimous support of the Upshur county Republicans was pledged to the gubernatorial nominee.

Dr. Hatfield was impressed with the sincerity of the demonstration. Predictions were made that he would carry Upshur county by the largest majority ever given a Republican candidate for governor.

Coming here from Grafton, where he addressed a large crowd last night, Dr. Hatfield was given informal receptions at several points along the line this morning. In his address this afternoon he lauded the achievements of the Republican administration of sixteen years in West Virginia. He urged the necessity of electing a Republican legislature to thwart the purpose of the Democrats to gerrymander the state and pass a law that

MARTIAL LAW

Is Declared by Governor Brown on Account of Riot at Strike Scene.

AUGUSTA, Ga., Sept. 28.—Martial law ruled here today as a result of disorders last night in which one citizen was killed and two wounded by militiamen guarding the property of the street railway company whose employees are on a strike. The fifth company of soldiers arrived today from Waynesboro and was placed at the power house where last night's shooting occurred.

Martial law was declared by Governor Brown, who sent Colonel W. L. O'Leary, of Savannah, to command the troops.

The men killed were not employees of the railway company but Augusta business men, who it is said refused to stop when challenged by guards.
