acts as to prevent them from standing together. It is a canon of statutory construction that a later statute, general in its terms and not expressly repealing a prior special statute, will ordinarily not affect the special provision of such earlier statute.

The repeal and simultaneous enactment of substantially the same statutory provisions is to be construed not as an implied repeal of the original statute, but as a continuation thereof.

The principle advanced in the foregoing authorities justifies the conclusion that said section, 219, is not repealed by implication, even though the provisions of the later act enlarge and make more stringent the punishment to be imposed for first offenses, but is a continuation of the original act.

When there are statutes clearly defining the jurisdiction of the courts the force and effect of such provisions should not be disturbed by mere implication flowing from subsequent legislation. In other words, where Congress has expressly legislated in respect to a given matter that express legislation must control, in the absence of subsequent legislation equally as express, and not to be overthrown by any mere inference or implication to be found in such subsequent legislation.

mer conviction or acquittal, the record of a justice may be introduced with like effect as that of a court of record, upon the same plea. 'It is, of course, inconvenient and perhaps impossible, at least difficult, for the prosecuting attorney to be constantly advised of proceedings before justices before who offenses under this statute are triable, but the argument from inconvenience addresses itself to the legislature and not to the judicial department of the state government, except that it may be considered by the latter in determining the extent of the legislative intent in the enactment of laws, when the intent is doubtful, but not otherwise.'
