

DEATH OF AN ENGLISH EDITOR.

Rev. Robert Roberts Suddenly Stricken With Heart Disease.

ROBERT ROBERTS, editor of the Christadelphian at Birmingham, England, arrived in this city on the Alameda last Wednesday from Australia and died suddenly yesterday morning in his room at the Cosmopolitan Hotel.



Mr. Roberts had purchased a ticket for New York by the Canadian Pacific Railway and a steamship ticket from New York to Liverpool and was to have started for Victoria yesterday morning.

Shortly after 8 o'clock one of the servants went to his room to inform him that a visitor was inquiring for him and found his dead body on the floor in front of the bureau.

The remains were taken to the morgue and a superficial examination led to the belief that death was caused by heart disease.

The dead man had more than a local reputation as a writer and lecturer on religious subjects and was on a lecturing tour around the globe.

His itinerary found among his papers shows that he had intended to stop at various places along the route to deliver lectures.

He was indirectly made by James Cheatham, a salesman for M. Friedman, the West street furniture dealer.

Mr. Cheatham promised to see Roberts on and called on that mission, when he was informed of the sad occurrence.

Roberts had written several works, among which are "Christendom Astray," "The Trial" and "Did Christ Rise?"

An examination of his effects disclosed a number of medicines used as remedies for heart troubles.

He leaves a widow and two daughters in Melbourne and a son in London.

The sad news has been wired to them and the remains lie in Porter's undertaking establishment awaiting their orders.

MARLOWE TELLS BURKE WAS DESERTED

Made a Bluff at Shooting Haynes.

WILKINSON WAS NOT IN SIGHT

COWARDLY METHODS OF THE ACCUSED OFFICERS.

Allowed Their Superior Officer to Be Shot Down in Cold Blood.

Further Hearing Continued.

The "brave" officers who deserted Lieutenant Burke when he was shot and killed by Theodore Park Haynes, the murderous tinker, were again before the Police Commissioners last night.

According to his story, which he told under oath, Burke appeared on the scene and he and his fellow-officers had turned tail and run.

Haynes had two revolvers, Burke told Wilkinson "stay back." He then approached the cabin, and encountering the murderous tinker, told him he was an officer, at the same time showing his war.

Haynes ordered him away, and as Burke refused to leave, the tinker fired at him.

As Burke fell mortally wounded he drew his revolver and fired at his assailant.

Haynes again fired, and Burke feebly attempted to shoot him, but did not have sufficient strength to pull the trigger of his revolver.

The witness denied that he had run away after Burke had been shot. He claimed that after his superior officer had fallen he retreated a few feet and fired three shots at the murderer.

"Why didn't you empty your revolver at Haynes when you saw him shoot down Lieutenant Burke?" asked Commissioner Tobin.

The witness replied that after he had "shifted his position" he fired the remaining shots from his revolver.

"After I had exhausted my ammunition," he remarked, "I shouted to Marlowe to get away from me."

"I did not see Wilkinson during the fight," he said.

Haynes fired a shot at me, the bullet striking within a foot in front of me. After Lieutenant Burke fell, Haynes retreated into the house.

I heard a peculiar noise, as if a shot had been fired, and concluded that he had committed suicide. I at once sent a boy for more ammunition.

"At this juncture I called to George Cashe, the patrol wagon driver, and said: 'For God's sake get Lieutenant Burke away from there.'"

He paid no attention to me, and I called to the driver to take the cabin and dragged Burke's body away.

Kennedy had a rifle, and he was ordered to get away from the scene. As I was reloading my pistol, having received fresh ammunition, I saw a man in a military uniform.

As Attorney Deuprey, who is prosecuting the case against the officers, was anxious to get the case closed, the hearing was continued until next Friday night.

HER ANTE-MORTEM STATEMENT TAKEN.

My husband has been jealous of me for the past three months. On the evening of the 21st last he came home about 8 o'clock in the evening and started to abuse me.

He threw me down and inflicted the injury from which I am suffering. He did this three or four times, hurting me intensely.

Notwithstanding the efforts of the police, Esqueda still enjoys her liberty. Captain Bohan, anticipating that the brute will attempt to leave the city, has detailed several of his best men to watch the ferries and railroad depots.

An officer has been stationed at his house, as it is believed that he will return, expecting to find his wife there.
