

PORT TOWNSEND, Wash., Nov. 15. The steamship Centennial of the Seattle and Honolulu line arrived this morning, bringing additional details of the misfortunes of the steamship Columbia of the same line. The Columbia was placed on the Seattle-Honolulu route and on her arrival at Honolulu she was covered with libel suits. After much delay the libels were temporarily satisfied and the vessel started on the return voyage October 23. From the time she left port defects were being found among various parts of her machinery which kept the engineering department busy fixing them, and the pumps commenced giving out one at a time. To add to these misfortunes a heavy northeast wind sprung up, the vessel rolled and pitched and the passengers were tossed about like leaves, it being impossible to walk either on deck or in the cabin. On November 31 the gale increased and it was found that a seam had opened amidships, that the steam pipes were straining badly and the vessel was being filled with escaping steam from the joints. Investigation showed that water was streaming in over the cement places on the sides of the room opposite the engines and that the boilers had broken down and their cement foundations were being washed away. Further investigation revealed the fact that seven streams from six to eight inches wide and one inch in thickness were pouring in amidships and another stream twelve inches wide was pouring into the fire room. The condition of the vessel became critical and Captain Milnor called the officers together for a conference and it became a fight for life. Boats were got in readiness for immediate use, and according to Captain Milnor it seemed impossible to reach port. Great coolness was displayed in the officers' department, while the bursting of the main steam pipe was momentarily expected, which meant death to all therein.

NEW YORK, Nov. 15.—The Washington correspondent of the Herald telegraphs: A cablegram received at the State Department from Acting Consul Baruch at San Salvador confirms the announcement of a revolution in Salvador. The message further states that President Gutierrez has been taken prisoner. No request for a warship is made, but in view of the seriousness of the situation it is probable that the orders to the Philadelphia will be changed so that she will start as soon as possible for the Salvadoran coast, or instructions will be given to the gunboat Wheeling to proceed to La Libertad and provide protection for American interests.

GAGE'S ELECTION NOW ASSURED

His Plurality Is Nearly Four Thousand.

FEW PRECINCTS YET TO COME

OFFICIAL FIGURES FROM MOST OF THE COUNTIES.

The Latest Returns Indicate That Gage Will Have a Plurality of Fully Twenty Thousand Over Maguire.

Later and fuller returns received yesterday indicate that the election of C. F. Curry as Secretary of State over R. A. Thompson is assured beyond a doubt.

Complete official returns have been received from thirty-five counties, partial returns from twenty counties and two counties—Alpine and Trinity—have not been heard from at all. The figures presented in the following table comprise the returns from 212 precincts out of the 2407 precincts in the State, and show a net plurality for Curry of 3896. The counties from which complete official returns have been received are indicated by a star.

Up to late last night complete official returns had been received from thirty-two counties, partial returns from twenty-four and one county—Alpine—had not been received. Figures were received from 2017 precincts out of the 2407 in the State. They showed a net plurality of 12,929 for Gage. Should Gage average a plurality of but two or three for the precincts to be canvassed he will pass the 20,000 mark.
