

FIGHT FOR LIFE AT A WEDDING CELEBRATION

Chantler and Heib Brothers Have a Lively Battle.

OLD FEUD BREAKS OUT ANEW

Life of One of the Heibs Probably Saved by the Prompt and Courageous Action of His Brother.

LODI, Nov. 4.—Michael Yeopp was married here yesterday, and his wedding day was fraught with excitement enough to serve him the balance of his days.

While the celebration was going on two brothers, named Frank and George Chantler, arrived and sent in word that they desired to see Michael.

The bridegroom refused to appear, fearing bodily injury, as the Chantlers had previously given him trouble.

The bride's brother, John and Jake Heib, expostulated with the intruders.

One of the Chantlers made a move for his revolver, and Jake Heib called to his brother in German to look out for their guns.

Heib seized the weapon, wresting it from his murderous assailant.

The other Chantler ran to his wagon and came back with a double-barreled shotgun.

He leveled it at young Heib, when the latter's brother grappled with him.

A wild struggle followed. Chantler pulled the trigger, but Heib's hand was below it and the weapon failed to discharge.

Heib finally overpowered the other and broke the shotgun to pieces over the fence.

The Chantlers jumped into their rig and drove hurriedly away. John Heib hurried to this place, but could not find an officer.

This morning the Chantlers returned and asked for their guns, but the weapons had been turned over to Constable Coleman.

The Chantlers have not yet been located, and Yeopp fears to have them arrested.

The case will be laid before the District Attorney to-morrow. An old feud is said to be the cause of the murderous attack.

Husband of the Erring Woman Visits Her at Phoenix.

MAY SECURE HER RELEASE

Woman Is Now Penitent and the Magnetic Healer Is Also Asking His Wife to Forgive Him.

PHOENIX, Ariz., Nov. 4.—C. W. Harris, the magnetic healer, and Mrs. C. M. Binford, who eloped from Los Angeles, are still in jail, but it is believed that the latter will be released in the morning.

Binford arrived in Phoenix this morning, and spent the day with his wife at the prison.

He had previously sent the following telegram to her: "Dear Clara: I will come to save you. You certainly must be hypnotized."

As soon as she had talked with her husband Mr. Binford repeats to her that she will return to him if she escapes punishment.

In an interview Binford said: "I shall do what I can to save my wife, but I shall also use every endeavor to send Harris to jail."

Mrs. Binford first took the matter as a joke, but she has been melancholy ever since the arrival of her husband.

She is the daughter of Judge C. M. Conpas of Los Angeles, who is assisting Binford to secure her release upon \$500 bonds.

Upon his arrest Harris wired to his wife for aid, although she had begun an action for divorce against him.

Mrs. Binford telegraphed her forgiveness, and she is expected to raise the necessary bonds. It is said that Harris was a train dispatcher in Chicago, and left that position for coming involved in a difficulty.

He has since been posing as a magnetic healer.

An alleged hold-up at the corner of Broadway and Sansome street was reported to the police at the Hall of Justice shortly after 6 o'clock yesterday morning.

William Jones, a mess boy on the transport Meade, claims he was followed for many blocks by three men, assaulted and robbed of \$25.

Jones told the police that the robbers started to follow him on Kearny street, near Market. He walked in the direction of the water front on Broadway, and when he reached Sansome street the men seized him, and he was thrown into a building.

They passed back to him, whereupon one of the men drew a revolver and threatened his victim with death if he made an outcry before they were out of sight.

The detectives worked on the case yesterday, but thus far no arrests have been made.

HOW MAN ATTAINS SUCCESS IN LIFE

Eloquent Words of Rev. Father Huntington in Y. M. C. A. Hall.

THE Rev. Father Huntington, the Episcopalian monk, lectured in the auditorium of the Young Men's Christian Association yesterday afternoon on "Success in Life."

There was a large audience present. Success in life, Father Huntington said, can only be attained by the direction of the energies toward the end for which God has fitted a man.

The difficulty was, he said, to find out just for what a man was best fitted, but this could be done by asking the only one who knew—God.

"A man's identity is divided into three parts," said the speaker, "his will, his heart and his mind. His mind is given him that he may know God; that he may learn of his infinite goodness and mercy and that he should love something that will uplift him and beget in him power and strength."

He said that if a man will only find it in God, if he loves purity, he will find it in God. But if he turns from God and loves only himself, his love will turn to hate and in time he will loathe himself.
